Public Comment Period

File No. 2017-00595, William T. Bradley

There were no public comments.

Regarding File Number 2017-00595, William T. Bradley, was present to address the Board. The Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigative file, transcript, exhibits, the Summary of the Informal Fact-Finding Conference, and the presiding officer's recommendation. Ms. Bennett moved to accept the recommendation of the presiding officer and to offer an Agreement for Licensure to include the following terms:

- This Agreement for Licensure shall remain in effect for two years from the date the license is issued;
- Bradley acknowledges that he has read the Virginia regulations and statutes that apply to the Auctioneers Board;
- During the term of this Agreement for Licensure, Bradley shall not violate any law or regulation in any state or jurisdiction, related to the practice of auctioneering;
- Bradley is to immediately report (within 48 hours) to the Board if he receives notice of any disciplinary investigation;
- Bradley further agrees that any violation of the terms of this Agreement for Licensure shall be deemed a violation of Board Regulation 18VAC25-21-180.1.

The motion also includes that the Agreement for Licensure must be executed by Mr. Bradley and returned to the Board within 30 days of receipt. If Mr. Bradley declines or fails to comply with this requirement, then his license application will be denied. Mr. Smith seconded the motion which was unanimously approved by members: Bennett, Smith, and Terry.

Regarding File Number 2016-02490, Paul Quinn, Quinn & Sons Inc., the Board members reviewed the Consent Order as seen and agreed to by Mr. Quinn, Quinn & Sons Inc. Mr. Smith moved to accept the Consent Order which cites the following violations of the Board's regulations: 18VAC25-21-110.A.2 (Count 1); 18VAC25-21-110.A.4 (Count 2); 18VAC25-21-110.A.7 (Count 3); and 18VAC25-21-110.B (Count 4). For these violations, Mr. Quinn, Quinn & Sons Inc., agrees to pay \$250 for the violation contained in Count 1; \$250 for the violation contained in Count 2; \$250 for the violation contained in Count 4; and \$150 in board costs, for a total monetary penalty of \$1,150. In addition for violation of Count 4, Mr. Quinn, Quinn & Sons Inc., agrees to complete at least three (3) classroom hours of Board-approved continuing education pertaining to a business

related topic, not to include bid calling or working the ring, i.e. Auction Verdicts; Business Practices; Ethics, and provide proof of attendance and successful completion within twelve (12) months of the effective date of this Order. The course(s) must be completed in the classroom. Ms. Bennett seconded the motion which was unanimously approved by members: Bennett and Smith. As the presiding Board member, Ms. Terry was not present for the discussion or vote.

Regarding **File Number 2016-00678**, **Tom M. Weaver**, the Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigative file, transcript, exhibits, the Summary of the Informal Fact-Finding Conference, and the presiding officer's recommendation. Mr. Smith moved to accept the Summary of the Informal Fact-Finding Conference as to the facts, which cites the following violations of the Board's regulations: 18VAC25-21-110.A.1.a (Count 1); 18VAC25-21-110.A.3 (Count 2); 18VAC25-21-110.A.7; (Count 3); 18VAC25-21-110.A.8; (Count 4); and 18VAC25-21-180.4 (Count 5). Ms. Terry seconded the motion which was unanimously approved by members: Smith and Terry.

File No. 2016-00678, Tom M. Weaver

Ms. Brooks informed the Board that Mr. Weaver had no prior violations.

For the violation contained in Count 1, the recommended sanction is a monetary penalty of \$50.00. Ms. Terry moved to accept the sanction for Count 1. Mr. Smith seconded the motion which was unanimously approved by members: Smith and Terry. For the violation contained in Count 2, the recommended sanction is a monetary penalty of \$25.00. Ms. Terry moved to accept the sanction for Count 2. Mr. Smith seconded the motion which was unanimously approved by members: Smith and Terry. For the violation contained in Count 3, the recommended sanction is a monetary penalty of \$25.00. Ms. Terry moved to accept the sanction for Count 3. Mr. Smith seconded the motion which was unanimously approved by members: Smith and Terry. For the violation contained in Count 4, the recommended sanction is a monetary penalty of \$25.00. Ms. Terry moved to accept the sanction for Count 4. Mr. Smith seconded the motion which was unanimously approved by members: Smith and Terry. For the violation contained in Count 5, the recommended sanction is a monetary penalty of \$300.00. Ms. Terry moved to accept the sanction for Count 5.
