To whom it may conscern,

The Board firmly believes that the public is best served by an open, responsible, and functional government. To date however, the COVID-19 pandemic has caused a significant disruption to the Board's ability to conduct in-person closed session inmate death investigations. This has resulted in a backlog in these critical investigations.

The Board must resume these closed-session inmate death investigations responsibly. To that end, the Board will meet in person on Thursday October 22, 2020 at the Department of Corrections Training Academy to conduct its first closed-session inmate death investigation since this pandemic began. This facility has sufficient room to accommodate the Board and its support staff while maintaining proper social distancing.

The public portions of this meeting will only address the appropriate closed session motions made pursuant to Virginia Code Section Virginia Code § 2.2-3711(16). It is anticipated that these public portions of the meeting will be less than five minutes in total. Because of the limited space available and the need for social distancing, it is requested that individuals who wish to attend the short public segments of this meeting, do so electronically by calling 1-916-750-3532 PIN #165723485 at 10:00 a.m. and 2:00 p.m. A transcript of the public portions of this meeting will be made available and posted to the Town Hall website.

The Board will make every effort to accommodate individuals who insist on personally attending the limited public portions of this meeting. The Board however, will utilize standard COVID-19 protocols. This will include COVID-19 specific health screening to gain entry into the building, the wearing of PPE at all times, and maintaining proper social distancing.
