The meeting began at approximately 9:45am.

#### Logistics:

The workgroup was introduced to the upcoming Qualtrics survey, which primary group members will be able to use to evaluate the proposals from the workgroups (WGS). The facilitators also reminded participants to submit minutes from any sub-group meetings.

## WG 2 & 3 Proposals:

Chip Dicks III (WG co-lead) presented the draft proposals from the joint Workgroups 2 & 3, starting at approximately 9:55. Broadly, the group discussed the conflict between the solar goals and conservation goals. He noted that the group had not come to a consensus about the functions and values of ecosystems. The workgroup was

interested in a checklist approach to define functions and values and appropriate mitigations. Solar groups were concerned about the impact of mitigations on solar as a least-cost utility. Broadly, the group agreed that mitigations could be on-site, off-site, or through the payment of in-lieu fees. Some group members felt that preference needed to be given to on-site or highly local mitigations. The WG 2 & 3 group then took questions and concerns from the broader RAP.

# **Questions and Updates:**

Workgroups 1, 4, and 5 were given a chance to update the larger RAP on their progress and/or ask any questions. Some comments regarding concerns about runoff and groundwater were voiced to WG 2 & 3, as well as continued concern about costs. Largely, the other WGs did not have any additional updates.

In the afternoon, all RAP members worked in their individual groups on their proposals.
