Enforcement Committee
Meeting Minutes
December 12, 2008

The Virginia Board of Accountancy's Enforcement Committee met on Friday, December 12, 2008, at 9960 Mayland Drive, Perimeter Center, 2nd Floor Conference Center, Richmond, Virginia 23233
