

**THE VIRGINIA BOARD OF ACCOUNTANCY**  
**Enforcement Committee**  
**Meeting Minutes**  
**April 19, 2010**

The Virginia Board of Accountancy's Enforcement Committee met on Monday, April 19, 2010, at 9960 Mayland Drive, Perimeter Center, 2<sup>nd</sup> Floor Commonwealth Conference Center, and Richmond, Virginia 23233
