Exit #150A onto ROANOKE RD [US-220-ALT] toward US-460 E/CLOVERDALE 5. Continue to follow US-220-ALT SOUTH
Turn on BLUE RIDGE BLVD [US-460]
Continue to follow US-460 EAST
Take ramp toward US-501 NORTH
Turn on CANDLERS MOUNTAIN RD
Arrive at 3777 CANDLERS MOUNTAIN RD, LYNCHBURG, on the right

Northern Virginia

I-66 WEST toward FRONT ROYAL/DULLES AIRPORT
Take exit #43B
Turn on US-29 SOUTH
Take the US-29 SOUTH exit toward LYNCHBURG/DANVILLE
Take ramp toward CHANDLERS MT RD
Turn on UNIVERSITY BLVD
Turn on CANDLERS MOUNTAIN RD
