# VIRGINIA REAL ESTATE BOARD EDUCATION COMMITTEE MEETING REPORT

The Real Estate Board Education Committee met on Wednesday, September 11, 2019, at 2:00 p.m., at the Department of Professional & Occupational Regulation in Richmond, Virginia.

Mr. Odems called the meeting to order at 2:03 p.m.

A motion was made to approve the agenda. The Committee approved it unanimously.

The Committee clarified its rationale regarding an instructor application that was not approved at the July 2019 meeting.

The Committee revisited the application and approved it.

The Committee approved the new Instructor's Resume Worksheet in order to help standardize resume information and eliminate extraneous information.

The Committee has received applications using the new Instructor's Resume Worksheet since the July 2019 meeting. Board staff has only received occasional complaints from previously approved instructors who did not want to fill out the new form. Board staff sought feedback from both the Committee and education providers who were present at the meeting. No specific feedback was provided.

The Committee requested that education providers stop including a traditional resume when an Instructor's Resume Worksheet has been included with the application. This is additional information that is not needed. An education provider asked whether the Instructor's Resume Worksheet should be comprehensive or specific to a course. The Committee did not give specific guidance, but affirmed that the worksheet should not include additional information beyond what is necessary for the Board to determine that the individual is qualified to teach the courses for which s/he is seeking approval.

The Committee requested that forms be filled in with a computer rather than by hand whenever possible.

The Committee understands that some individuals are still having difficulty downloading and opening the Board's forms from the website. However, the Committee emphasized that handwritten applications are sometimes unreadable.

In the future, when Board staff notices a hand-written application, it will send the application form by email and request it be completed electronically.

Board staff consulted the Committee about its proposed policy for education providers seeking to offer a course that was previously approved for another school.

Board staff proposed that it would contact the education-provider-seeking-approval if the original course was expiring within two months. This will allow the education-provider-seeking-approval to determine if it would rather wait until the new course is renewed, and it will also help ensure that the provider is aware that the approval is limited to the expiration of the original course.

Board staff will provide the Committee with files in a new format for the November meeting.

Currently, Board staff compiles the files for the meeting into a single pdf document. There are numerous problems with the compilation that leads to corrupted files. Although Board staff has sought to minimize these issues, compiling the Committee file can still be a long and difficult process. In the process of seeking a solution, Board staff has reason to believe that compiling the files as a pdf portfolio will yield better results and proposed implementing this method for the next Committee meeting.

The Committee agreed to the request, pending a trial run with the new file format in the next few weeks.

## Public Comment.

An education provider asked whether education providers are required to submit a candidate photograph to PSI or whether this is the responsibility of the candidate. The education provider mentioned that there is currently no information regarding the need for a photograph in the bulletin. Board staff confirmed, however, that the requirement is in the contract between the Department and PSI. A second question concerned who should provide the photograph if there is more than one education provider. A third question concerned whether a provider is required to keep photographs along with student records. Board staff will research the proper procedure for photograph submission to PSI, as well as having PSI update the information provided in the bulletin. Board staff will report back at the next meeting.

An education provider asked whether distance learning courses must be resubmitted in their entirety when the only change is a software change (for instance, to the timing mechanism) but all content remains the same. The Committee stated that such a course would not need to be resubmitted if the change is to software but course content remains the same.
