Eric Olson, Executive Director, informed the Committee the new Misclassification Prohibited Act is still a matter of great interest with the class attendees, as they are confused regarding the IRS requirements and voice a strong concern about how to solve the labor shortage issue in the light of the employee classification requirements. Class attendees have many questions regarding the misclassification that staff is unable to answer and currently direct them to call the tax authorities (IRS/VaTax), their CPA/bookkeeper, or tax attorney. Staff continues attempts to have a representative from the Department of Taxation teach the class.

Eric Olson, Executive Director informed the Committee at its last Board for Contractors Meeting on September 14, 2021 the Board adopted a temporary reduction in renewal fees for contractor licenses in order to reduce an accumulated surplus in its budget and to be in compliance with the Callahan Act. Mr. Olson updated the Committee Exempt Regulatory package is Final and will become effective December 1, 2021.

Eric Olson, Executive Director informed the Committee the Regulatory Review process to amend the language for Prohibit Act 9.b. is still at the Governor's office.

Marjorie King, Board Administrator informed the Committee PSI is performing remote pilot examinations with a remote proctor. Currently 11 other states are offering remote testing. PSI would like the Board for Contractors to do a pilot period for HIC.

### **AES Policy**

Eric Olson, Executive Director informed the Committee staff has received complaints from AES Contractors regarding the policy adopted by the Board that allows AES Contractors to install alternative energy systems that do not exceed 100KW. In order to install alternative energy systems that generate more than 100KW would require that the contractor hold a license with the H/H classification. AES Contractors have asked that the Board reconsider changing from 100KW to 500KW in order to accommodate larger solar projects.

After discussion, a motion was made by Mr. Hux and seconded by Mr. O'Dell to allow staff to research 100kw to 500kw to the insure the sufficient amount of kw is being given.
