#### Purpose of the Workgroup

Chairman Hux, informed the workgroup they shall study the efficacy of the Commonwealth's occupational licensing laws for construction trades to (i) determine whether more requirements are necessary to ensure all workers in relevant crafts are licensed, (ii) determine whether greater occupational licensing enforcement is necessary, (iii) determine whether the Commonwealth's occupational licensing laws should apply to a broader scope of construction trades, and (iv) make recommendations for new laws or policies that would enhance the Commonwealth's occupational licensing regulations.

Public Comment Public Comment

Jack Dyer, I was a Board Member and Chairman for the Board for Contractors for many years, I have also been a commercial contractor for over 40 years.

Line 4 of the resolution states "Establishing a joint subcommittee to study the efficacy of the Commonwealth's occupational licensing laws for construction trades" The word efficacy means "The ability to produce a desired or intended result" Has the Board for Contractors not been doing this already. We research, discuss, and debate the regulations every year. Regarding lines 12-15, the Board for Contractors regulations already covers licenses for Contractors and Tradesman, which were passed by the General Assembly, and through numerous administrations. The Board for Contractors looks to protect the health, safety, and welfare of the public. As far as the quality of work and safety of the job would be handled by VOSH, not the Board. Improving the Boards regulations is great, but fixing what is not broken it not necessary. Over regulating will not bring contractors into the trades, it will only deter them, and effect our economy more.

Lou Spencer, with the Plumbers and Gasfitters local union #5, and Assistant Business Manager. Mr. Spencer is a concerned citizen with the problems in Northern Virginia regarding the numerous amount of unlicensed contractors and tradesman.

#### A Basic Licensing Primer

A Basic Licensing Primer

Recess

Eric Olson, Director gave an overview of the Board for Contractors. The Board for Contractors is the largest Board licensing 88,000 contractors. Currently the Board regulates Contractors, Residential Building Energy Analyst businesses and individuals, Tradesmen (plumbing, electrical, HVAC, gas-fitting) – two levels, Backflow Prevention Device Workers, Elevator Mechanics, Accessibility Mechanics, Water Well System Providers – three levels, Drug Lab Remediators, and Fire Sprinkler Inspectors.

Mr. Olson reviewed the difference between regulations and the law. All of the Board's authority comes from the law. The Board operates under the Administrative Process Act, FOIA, and applicable sections of Title 54.1 of the Code of Virginia. The Board does not get to choose which programs to regulate with the exception of the addition or subtraction of specialties for contractors. The Board only has authority over licensed individuals, and the General Assembly must pass legislation to add/delete regulatory programs.

In this workgroup we are looking at studying the efficacy of current occupational licensing laws for construction trades, determine whether more requirements are necessary to ensure licensure, determine whether greater enforcement is necessary, determine whether the licensing laws should apply to a broader scope of trades, and make recommendations for new laws or policies that would enhance the current licensing regulations.

The workgroup discussed why adding more certification or regulation requirements would benefit or hinder the construction and trade industry. After much discussion it was recommended to have a voluntary certification program that would exempt a qualified individual of a license from sitting for the required examination of licensure. Some concerns of the voluntary certification program are the already increasing number of Spanish speaking contractors and trades that are unable to complete the examination requirements of licensure and how would this help them.

Mr. Olson, Director informed the workgroup with regards to his working with the Latino Advisory Council in providing it information on the licensing requirements, exams, and applications for its programs. It was noted that the Council is exploring the possibility of having exams and applications be given in Spanish now that the ICC has published Spanish editions of the International Building Codes.

New Individual Licenses/Certification Recommendations

The workgroup identified 12 possible individual license and certification programs to bring forward for discussion. These included: Carpenters, Masons, Painters, Sheetrock Installers, Fire Sprinkler Installers, Roofers, Insulation Installers, Framers, Concrete/Cement Workers, Flooring Installers, Tilers, and Glaziers.

New Individual Licenses/Certification Recommendations

After discussion of each individual program and review of any national certification programs currently in place for these vocations, the workgroup recommended the list be reduced to the following and further discussion at the next meeting should be conducted to determine if they should be recommended for voluntary certification and subsequent exemption from the current Qualified Individual examination, frapplicable.

- Carpenters
- Masons
- Sheetrock Installers
- Painters will be deferred to the next meeting after additional information is provided to the workgroup to determine if there is a national certification program already available.
