Revised reciprocal Agreement with Maryland -Update

Marjorie King, Executive Director informed the Committee the Maryland Board agreed with the revised agreement, that would remove the statement of nonresidents of Maryland, and would include adding journeyman to the reciprocal agreement. The agreement went into effect on July 17, 2023.

**Education Provider Audit** 

Germanna Community College Bill Ferguson provided a report for the pre-license education course he audited.

On June 17, 2023, Mr. Ferguson audited a contractor business pre-license course given by Germanna Community College. This was an unannounced audit of the course titled Basic Contractor Business

Licensing Class. The instructor was Donald Thomas. The course's location and date were in agreement with the course information on the education provider's website. After briefing the Committee of the audit details the following recommendations were made to the Committee.

Since the instructor's qualifications have not been submitted to the Board, Board staff should request Germanna Community College to include the instructor's information as part of future applications.

Based on the open floor plan of the building and the foot traffic though the classroom area during the course, Board staff should request Germanna Community College to conduct the course in the enclosed classroom if possible or, in the open area, to place temporary barriers to prevent persons from walking through the class while it is progress. Temporary signage informing persons in the building that a class was in session may be helpful also.

Marjorie King, Executive Director informed the Committee many electrical stakeholders have expressed concerns regarding the eligibility proposed for the Residential Journeyman Electrical license. Stakeholders, recommend keeping the current eligibility requirements for Electrical tradesman licenses and eliminating Residential Journeyman Electrical from the proposed regulations.

A motion was made by Lowe seconded by O'Dell to remove Electrical from the proposed Residential Journeyman license within the Individual Eligibility regulatory package and move forward with Residential Journeyman Plumbing and HVA only.


