

FINAL MINUTES
Milk Commission Meeting Held February 16, 2018

Minutes of the meeting of the Milk Commission, held at the Farm Credit of the Virginias located at 4646 South Valley Pike, Harrisonburg, VA 22801.

THE COMMISSION:

PRESENT: Gerald Heatwole, Chairperson; James Kerr, Commissioner; Bruce Mayer, Commissioner; Crafton Wilkes, Administrator.

Absent:

Carolyn Carlson, Commissioner; Jay Swanson, Commissioner; Kate Farmer, Commissioner; Patrick Crawford, Commissioner.

Board members called the meeting to order at 1:30 p.m.

Mr. Heatwole asked for a motion to accept the minutes from the previous meeting. Mr. Kerr so moved and Mr. Mayer seconded the motion. The minutes were accepted as presented at the meeting.

Mr. Wilkes gave a review of Class I and Class II sales and pricing, as well as retail pricing and presumed delivery cost. Producer prices have continued to decline, but there are hopes that March will mark the bottom and price will rebound soon. Mr. Wilkes noted that retailers were currently not racing to meet the legally acceptable minimum price, which is an indication that the price is exceptionally low. He also noted that USDA AMS had reported on its *Estimated Fluid Milk Products Sales Report* that milk sales in the United States had declined 2.1% through November 2017.

Mr. Wilkes provided the board with information regarding a proposed change to the delivered case categories established in 2VAC15-20-100, Rules of Practice. The established case categories are currently less than 14, 14-99, and 100 or more cases per delivery. The proposed amendment would establish the case categories as less than seven, 7-99, and 100 or more cases per delivery. Mr. Wilkes stated that this change may have some effect on the price of milk offered by smaller retailers, but the overall impact would likely be minimal as most milk is purchased at larger retail stores. He also emphasized that he believed there was confusion among smaller retailers who believed that the Milk Commission caused their wholesale price to be significantly greater than larger retailers when, in fact, the wholesale price represents the actual cost to deliver smaller quantities to remote locations. Mr. Mayer shared information he had collected from several stores and indicated that he was concerned that the proposed changes could result in distributors no longer serving those stores, which would make getting milk more difficult for some families in rural communities. Mr. Wilkes read the following motion: The Milk Commission will adopt amendments to 2VAC15-20-100, Rules of Practice, as presented by staff today and that the Commission authorizes staff to take any and all steps necessary to amend this regulation through a fast-track regulatory action. This motion was accepted by Mr. Mayer and seconded by Mr. Kerr, and the Commission approved to amend the regulation.

Mr. Wilkes presented and discussed the 2018 established bases as required by regulation. 2VAC15-20-40 states that producer bases cannot exceed 1.08% of the average monthly pounds of Class I sales for all months excluding June, July, and August. Having considered all factors relative to the establishment of the 2018 base adjustments, upon a motion by Mr. Mayer and seconded by Mr. Kerr, the Commission approved the base adjustment of the bare minimum necessary to be in accordance with 2VAC 15-20-40. Existing producer base will be decreased 2.5405% on March 1, 2018 to include base loss and base recovered. The amount of base for the months of June, July and August shall be equal to 93% of the established base for the remaining months of the year. The 2018 base allotments, in total by cooperatives, as listed below, are therefore, established for the existing baseholding producers, effective March 1, 2018:
