A motion was made by Mr. Doherty and seconded by Mr. Dudley to Agenda approve the agenda. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam and Minter.

A motion was made by Mr. Doherty and seconded by Mr. Dudley to Minutes approve the June 4, 2014, Board Meeting minutes and July 29, 2014, Cemetery Board Committee Meeting minutes. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam and Minter.

In the matter of File Number 2015-00544, Frances Gill, the Board reviewed the record which consisted of the application file, transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding officer. A motion was made by Mr. Doherty and seconded by Mr. Minter to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference and, after consideration of the criteria contained in § 54.1-204.B of the Code of Virginia, approve Ms. Gill's application for a cemetery sales personnel registration. The motion passed unanimously. Members voting "Yes" were Butler. Doherty, Dudley, Gilliam, McDaniel and Minter.

In the matter of File Number 2015-01038, Barbara Ann Lynch, the Board reviewed the record which consisted of the application file. transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding Board member. A motion was made by Mr. Doherty and seconded by Mr. Dudley to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference and approve Barbara Ann Lynch as the trustee of the preneed trust funds for C. C. Williams Memorial Park, Inc. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam and McDaniel.

As the presiding Board member, Mr. Minter did not participate in the discussion or vote in this matter.

In the matter of File Number 2015-01278, Greenlawn, LLC, the Board reviewed the record which consisted of the application file, transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding Board member. A motion was made by Mr. Doherty and seconded by Mr. McDaniel to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference and approve John William Brennan as the trustee of the perpetual care and preneed trust funds for Greenlawn LLC contingent upon the Board's receipt of the fidelity bond with corporate surety, payable to the trust, in sum equal to not less than 100% of the value of the trust. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam and McDaniel.

As the presiding Board member, Mr. Minter did not participate in the discussion or vote in this matter.

In the matter of File Number 2015-01563, Jacqueline Marrow, the File Number 2015-01563, Board reviewed the record which consisted of the application file, Jacqueline Marrow

transcript and exhibits, and the Summary of the Informal Fact-Finding Conference of the presiding officer. A motion was made by Mr. Minter and seconded by Mr. Doherty to accept the recommendation contained in the Summary of the Informal Fact-Finding Conference and, after consideration of the criteria contained in § 54.1-204.B of the *Code of Virginia*, approve Ms. Marrow's application for a cemetery sales personnel registration. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam, McDaniel and Minter.

In the matter of File Number 2014-00278, Maranatha LTD, t/a Merchants Hope Memorial Gardens, the Board reviewed the Consent Order as seen and agreed to by Maranatha LTD, t/a Merchants Hope Memorial Gardens. A motion was made by Mr. McDaniel and seconded by Mr. Minter to accept the proposed Consent Order offer wherein Maranatha LTD, t/a Merchants Hope Memorial Gardens, admits to seven violations of § 54.1-2319 (Count 1) of the Code of Virginia, sixteen violations of § 54.1-2325 (Count 2) of the Code of Virginia, two violations of § 54.1-2330 (Count 3) of the Code of Virginia, a violation of § 54.1-2324 (Count 4) of the Code of Virginia, and a violation of § 54.1-2333 (Count 5) of the Code of Virginia and agrees to a monetary penalty of \$100.00 for each violation contained in Count 1, \$100.00 for each violation contained in Count 2, \$100.00 for each violation contained in Count 3, and \$150.00 in Board costs, for a total of \$2,650.00. In addition, for violation of Counts 1, 2, 3, 4, and 5, Maranatha LTD agrees to make necessary changes, to include "trust," in both the perpetual care and preneed accounts so that they are held in accordance with §54.1-2316 and \$54.1-2325, respectively, and further to provide satisfactory proof thereof to the Board within 60 days of the acceptance of the order. The Board will waive imposition of \$600.00 of the monetary penalty for Count 1. \$1,500.00 of the monetary penalty for Count 2, and \$100.00 of the monetary penalty for Count 3, provided Maranatha LTD deposits \$74,104.60 into its preneed trust fund and provides proof acceptable to the Board thereof within sixty (60) days of the effective date of the order. If Maranatha LTD fails to comply with these conditions, then the full monetary penalties will be automatically imposed. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam, McDaniel and Minter.

of § 54.1-2319 (Count 3) of the Code of Virginia, and two violations of § 54.1-2325.A (Count 4) of the Code of Virginia, and agrees to a monetary penalty of \$100.00 for the violation contained in Count 1, \$100.00 for the violation contained in Count 2, \$150.00 for the violation contained in Count 3, \$150.00 for each violation contained in Count 4, and \$150.00 in Board costs, for a total of \$800.00. The motion passed unanimously. Members voting "Yes" were Butler, Doherty, Dudley, Gilliam, McDaniel and Minter.
