October 17, 2006

The Cemetery Board met on October 17, 2006, at the Department of Professional and Occupational Regulation (DPOR), 3600 West Broad Street, Richmond, Virginia. The following members were present:

Mr. Bell called the meeting to order at 9:07 AM

Call to Order

William A. Tucker, a member of the Board for Professional and Public Comment Occupational Regulation, was present to observe the proceedings of the Board meeting. No one addressed the Board during the Public Comment period.

A motion was made by Ms. Berney and seconded by Mr. Doherty to Agenda approve the agenda. The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, Gleason, and Kirsch.

Berney, Gleason, and Kirsch.

A motion was made by Ms. Berney and seconded by Mr. Doherty to Minutes adopt the following minutes: June 7, 2006, Board Meeting. The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, Gleason, and Kirsch.

In the matter of File Number 2006-03122 Larry D. Davis, the Board File Number 2006-03122 reviewed the records which consisted of the Consent Order. A motion Larry D. Davis was made by Mr. Kirsch and seconded by Mr. Gleason to accept the Consent Order wherein Mr. Davis admits to a violation of §54.1-2314.2 of the Code of Virginia (7 violations) and agrees to a monetary penalty of \$2,500.00 for each violation contained in Count 1 and agrees to pay \$150.00 in Board costs for a total of \$17,650.00. In addition, for the seven (7) violations of Count 1, Mr. Davis agrees to voluntarily surrender all of his cemetery sales registrations and/or licenses within thirty (30) days of entry of this order by the Board. If such surrender is timely made, the Board will waive \$16,800.00 (7 x \$2,400.00) of the total monetary penalty, resulting in a total monetary penalty of \$700.00. Also, Mr. Davis agrees to never apply for another Virginia cemetery sales registration and/or license. Members voting "Yes" were Bell,

As the reviewing Board member of the Consent Order file, Mr. Doherty did not participate in the discussion or vote pertaining to this matter.

In the matter of File Number 2006-04037 Associated Cemetery Consultants, Inc., the Board reviewed the record which consisted of the Consent Order. A motion was made by Mr. Bell and seconded by Mr. Doherty to accept the Consent Order wherein Associated Cemetery Consultants, Inc. admits to a violation of 18 VAC 47-20-200. C of the Board's 2005 Regulations (18 violations)(Count 1), §54.1-2325.A (16 violations)(Count 2), §54.1-2324.A (Count 3), and §54.1-2333.A (Count 4), of the Code of Virginia and agrees to a monetary penalty of \$500.00 for the violation contained in Count 1, \$500.00 for the violation contained in Count 2, \$100.00 for the violation contained in Count 3, and \$100.00 for the violation contained in Count 4, and agrees to pay \$150.00 in Board costs for a total of \$1,350.00. In addition, for violation of Counts 1 and 2, Associated Cemetery Consultants, Inc. agrees to provide documentation, in a form acceptable to the Board, that the deposit shortages/excesses have been corrected, within thirty (30) days of entry of this Order. The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, Gleason, and Kirsch.

Arrival of Board Member

In the matter of File Number 2006-04295 Jet Industries, Inc., the File Number 2006-04295 Board reviewed the record which consisted of the Consent Order. A Jet Industries, Inc. motion was made by Mr. Doherty and seconded by Mr. Kirsch to accept the Consent Order wherein Jet Industries, Inc. admits to a violation of 18 VAC 47-20-190.13 (Count 1), and 18 VAC 47-20-220 (Count 2) of the Board's 2005 Regulations and agrees to a monetary penalty of \$2,000.00 for the violation contained in Count 1, and \$200.00 for the violation contained in Count 2 and agrees to pay \$150.00 in Board costs for a total of \$2.350.00. In addition, the Board shall waive \$1,800.00 of the monetary penalty for Count 1 provided Jet, Industries reimburses \$750.00 to Sharon L. Johnson and provides the Board with proof of payment within sixty (60) days of the effective date of this Order. If Jet Industries, Inc. fails to comply with these conditions, then the full monetary penalty will be automatically imposed. The motion passed Members voting "Yes" were Bell, Berney, Doherty, unanimously. Gleason, King, and Kirsch.

In the matter of File Number 2006-04984 Greenwood Acres, LLC, the Board reviewed the record which consisted of the Consent Order. A motion was made by Ms. Berney and seconded by Mr. Doherty to accept the Consent Order wherein Greenwood Acres, LLC admits to a violation of 18 VAC 47-20-200.C (four violations) of the Board's 2005 Regulations and agrees to a monetary penalty of \$100.00 for each violation and agrees to pay \$150.00 in Board costs for a total of \$550.00. It is noted that due to the circumstances of this subject matter and that Greenwood Acres, LLC has not been previously disciplined by the Board, the imposition of the \$400.00 monetary penalty shall be waived. The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, Gleason, King, and Kirsch.

In the matter of File Number 2006-05397 Merchants Hope Memorial Gardens, the Board reviewed the record which consisted of the Consent A motion was made by Mr. Kirsch and seconded by Mr. Doherty to accept the Consent Order wherein Merchants Hope Memorial Gardens admits to a violation of 18 VAC 47-20-200.C (seven violations)(Count 1) of the Board's 2005 Regulations and §54.1-2325.A (seven violations)(Count 2) of the Code of Virginia and agrees to pay \$150.00 in Board costs. It is noted that due to the circumstances of this subject matter and that the new owners of Merchants Hope Memorial Gardens have not been previously disciplined by the Board no monetary

The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, Gleason, King, and Kirsch.
