CALL TO ORDER: , A Special Conference Committee of the Board was called to

order at 10:17 a.m.

PRELIMINARY MATTER: The Chair noted that the time was 10:17 a.m. and Mr. Stephen

Scott was noticed to appear before the Committee at 10:00

a.m. and was not present.

Ms. Tatum advised that the Notice had been sent to Mr.

Stephen Scott. address of record with the Board by Certified

and First-class mail.

RULING: Based on the information provided by Ms. Tatum, the Chair

determined that proper notice had been provided to Mr. Scott, therefore, the informal conference would proceed in his

absence.

DISCUSSION: Mr. Scott did not appear before the Committee in accordance

with the Board's Notice of Informal Conference dated October 18, 2022, nor was he represented at the conference by legal

counsel.

The Committee fully considered the evidence before it and

received information from Ms. Tatum regarding the allegations

in the Notice.

CLOSED SESSION:

Upon a motion by Dr. Fox, and duly seconded by Dr. Adler, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Mr. Scott Additionally, he moved that Ms. Tillman Wolf and Ms. Venable attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.

DECISION:

Upon a motion by Dr. Adler, and duly seconded by Dr. Fox, the Committee made certain findings of fact and conclusions of law and voted to issue Mr. Scott an Order of Reprimand and an Order to place Mr. Scott on indefinite probation with ability to petition for end to probation after 18 months of active Physical Therapy practice.

VOTE:

The vote was unanimous.

ADJOURNMENT:

The Committee adjourned at 11:18 a.m.

As provided by law this decision shall become a Final Order thirty (30) days after service of such Order on Mr. Scott, unless a written request to the Board for a formal hearing on the allegations made against him is received from Mr. Scott, within such time. If service of the Order is made by mail three (3) additional days shall be added to that period. Upon such timely request for a formal hearing, the decision of the Special Conference Committee shall be vacated.
