Following the Governor's approval, the NOIRA will be published in the Virginia Register of Regulations, at which time a 30 day public comment period will commence.

New Business

Non-Traditonal Classroom Instruction

Mr. Melis provided the Board with a history of online instruction in Board licensed schools, beginning with the Board's vote on 6/9/2003 to accept online training for the theory portion of an approved program. The exact number of schools offering online instruction for the theory portion of programs is unknown.

After discussion and a review of 'best practice' and overall 'general standards' in non-traditional classroom instruction, the Board reached a consensus that schools may offer, at the Board's discretion, non-traditional or 'online' instruction provided that the school has demonstrated, in a manner and format prescribed and acceptable to the Board, that:

 Only the 'general' or 'intro' portions of the curriculum which are common across all professions regulated by the Board may be offered online. All other theory instruction must be obtained in a Board for Barbers and Cosmetology DRAFT Minutes of Meeting May 13, 2013 Page 15 of 16

traditional brick and mortar classroom setting.

- The school provides sufficient information to show it utilizes technologies and practices that are effective in verifying the identity of distance-learning students who participate in class or coursework (such as a secure login and pass code) while protecting student privacy.
- The curriculum package submitted for Board approval is equal in content and thoroughness to that required of a traditional classroom program.
- There is a measure of competency of the information the student is taught online completed in a traditional brick and mortar classroom.

A Non-Traditional Classroom Instruction guidance document will be drafted and presented to the Board at its next regularly scheduled meeting.

Mr. Harrell initiated a discussion of health education for tattooers and body piercers, and the need for ensuring that health education providers that are accepted by the Board meet the appropriate standards for such education. Acceptable Health
Education Providers

After discussion the Board reached a consensus that only Health Education providers in conformance with and authorized to teach the standards and methods of the American Safety & Health Institute (ASHI), the American Red Cross, the American Heart Association, or other equivalent programs approved by the Board. A guidance document will be drafted and presented to the Board at its next regularly scheduled meeting.

Mr. Melis asked for the Board's guidance regarding the definition of "substantially equivalent" training as mentioned in 18 VAC 41-20-30, 18 VAC 41-40-30, 18 VAC 41-50-30, 18 VAC 41-60-30, and 18 VAC 41-70-30. License by endorsement.

After discussion, and upon a motion by Mr. Anders that was seconded by Ms. Crawford, the Board voted to adopt the following policy:

When staff are assessing license by endorsement applicants for the referenced professions, in order to qualify as having substantially equivalent training, an applicant must have completed both a training program and a written and practical examination that is substantially

equivalent to the respective applicable regulations. Pertaining specifically to the training, in order to be eligible, the applicant must have at least 80% of the hours Virginia requires and provide documentation of six months of full time work experience in the preceding three years in the respective field.

The members voting 'yes' were Mr. Anders, Mr. Chapman, Ms. Crawford, Ms. Dorey, Ms. Mayhue, Mr. Minor, Ms. Quinn, and Ms. Tsamouras. There were no negative votes. The motion passed unanimously.

Staff will implement the Board's definition of substantially equivalent training in the processing of endorsement applications immediately.

Mr. Melis reported on his attendance at the National Interstate Council of State Boards of Cosmetology (NIC) All Regions Meeting in Charlotte, NC from 4/18 through 4/23/2013.

Report on NIC Conference

Mr. Melis reported on U.S. Dept. of Education regulations set to go into effect July 1, 2013 which require that schools, including schools licensed by the Board, which wish to participate in Title IV Federal Student Aid programs, must comply with. The two main points schools must ensure they are in compliance with are: 1) they are authorized by the Commonwealth to offer post-secondary education, and 2) their students have access to a formal complaint process managed by the state.

Certification of Post-Secondary Educational Programs

Mr. Melis further reported that DPOR cannot authorize a school as 'post-secondary,' only the State Council of Higher Education for Virginia (SCHEV) has the statutory authority to do so. In consultation with SCHEV it was determined that although schools licensed by the Board to teach the Board's programs are exempt from the requirement for SCHEV licensure, schools may obtain SCHEV certification which may assist the school in meeting federal mandate.

There being no other business to be brought before the Board, Mr. Minor adjourned the meeting at 12:43 P.M.
