The members voting 'yes' were Mr. Anders, Mr. Chapman, Ms. Dorey, Ms. LaPierre, Ms. Mayhue, Ms. Quinn, and Ms. Tsamouras. There were no negative votes. The motion passed unanimously.

Mr. Melis presented the Public Comment Summary and recommended responses related to the 2013 Regulatory Review.

The Board reviewed the proposed amendments to the Barbering and Cosmetology Regulations. Mr. Courtney provided the Board with an overview of the regulatory review process.

Mr. Melis discussed with the Board state authorization of post-secondary schools. DPOR, in consultation with its counsel, was advised it cannot authorize a school as 'post-secondary' as, in Virginia, only SCHEV is statutorily granted said authority. In collaboration with SCHEV staff, it was determined that although schools may be exempt, schools licensed by DPOR may obtain SCHEV certification. SCHEV advised it would assist schools in the certification process.

SCHEV and DPOR continued to evaluate the issue through their respective counsel and SCHEV agreed it will retain oversight and certify

eligible schools who wish to voluntarily be certified.

Mr. Melis informed the Board that the request for proposal for the Board's exam vendor contract is being re-advertised. While the procurement process continues, the contract with the current vendor, Professional Credential Services, Inc., has been extended for six months beyond the 12/31/2013 expiration date.

Examination Vendor Update

Mr. Melis discussed with the Board the potential of developing a state examination and ceasing to administer a national examination, such as the current national examination in use, the National-Interstate Council of State Boards of Cosmetology (NIC) examination currently being administered by PCS. Mr. Melis indicated that developing a state examination may contribute to reducing the incidence of examination fraud while also having the ability to control the content of the examinations.

Upon a motion by Ms. Tsamouras and seconded by Ms. Mayhue, the Board voted to require any prospective examination vendor to develop all new original examinations for its professions, which would be exclusive to Virginia, and not have any material similarities in whole or in part with any other existing examinations, to include but not limited to the NIC examinations.

The members voting 'yes' were Mr. Anders, Mr. Chapman, Ms. Dorey, Ms. LaPierre, Ms. Mayhue, Ms. Quinn, and Ms. Tsamouras. There were no negative votes. The motion passed unanimously.

After discussion, the Board agreed that a state-developed examination would initially be offered only in English.

Mr. Chapman agreed to work with Mr. Melis on reviewing proposals.

Mr. Melis discussed with the Board the practice in which some licensed schools are engaging, of accepting transfer students from other licensed Virginia schools and providing the students with credit for previously completed hours. After discussion, the Board consensus is that there are no Barber and Cosmetology regulations that permit the transfer of hours from one school to another.
