Ms. Elizabeth Britt-Kelly, Cosmetology Instructor at the Virginia Beach/Norfolk Technical Center reiterated Ms. Welton's concerns with regard to the technical center's Spring 2015 exam candidates.

Regulatory Review
Report

Mr. Melis reviewed the proposed Barbering and Cosmetology Regulations, previously approved by the Board on November 18, 2013. The Regulations are currently in Executive Review. Mr. Melis explained that the Executive Branch requested that the Board review its proposed prohibition of animals in salons, shops, and spas. Proposed Barber and Cosmetology Regulations - Amendment
