Mr. Quesenberry asked if Board staff or Board members would be involved in the exam review. Mr. Melis indicated that he will make inquiries and report back to the Board about the review.

Reports

Mr. Kirschner reported that the Department of Education (DOE) participated in the Ad Hoc Committee on Career and Technical Education, and that staff continues to communicate with DOE representatives. The Committee will meet again to provide its recommendations to the DOE.

Ad Hoc Committee on Career and Technical Education

Mr. Kirschner reported that the Barbers and Cosmetologist Regulations and the Esthetic Regulations are at the Governor's office for review and that the next phase of the review process would be the Public Comment Period.

Regulatory Review Report

Mr. Kirschner reported that no legislation impacting the Board was passed by the General Assembly and the three bills that could have

New Business

Board Guidance

Mr. Kirschner reported that there are two items on which staff is requesting guidance from the Board.

Eyebrow Embroidery

The first item for the Board's consideration is the practice of eyebrow embroidery. Mr. Kirschner indicated that staff had conducted further research into the practice, and had determined that eyebrow embroidery is a semi-permanent procedure that removes skin of the epidermis and applies ink that lasts from 1 to 3 years.

Upon a motion by Mr. R. Jones and seconded by Mr. T. Jones, the Board voted to provide its guidance that eyebrow embroidery is not in the scope of practice of a tattooer or permanent cosmetic tattooer.

The members voting 'yes' were Ms. Dorey, Mr. R. Jones, Mr. T. Jones, Ms. LaPierre, Mr. Quesenberry, Ms. Quinn, and Ms. Tsamouras. There were no negative votes. The motion passed unanimously.

Mr. Kirschner initiated a discussion of Regulation 18 VAC 41-20-50.B with regard to credit for performances for barbers or barber students seeking to enroll in cosmetologist training or cosmetologists or cosmetologist students seeking to enroll in barber training.

18 VAC 41-20-50.B Education Credit for Performances

After an initial discussion, the Board reached a consensus that barber students could obtain credit hours for performances completed during cosmetologist training, and cosmetology students could obtain credit hours for performances completed during barber training.

The Board further discussed credit hours and how the hours should be awarded. The Board agreed that hours awarded must be based upon hours on the school transcript.

Upon a motion by Ms. Dorey and seconded by Ms. Tsamouras, the Board voted to provide its guidance that credit awarded pursuant to 18 VAC 41-20-50.B, speaking to training received for performances in cosmetology or barbering school, will consist of the number of performances and the number of hours recorded in the school's transcript, will only be awarded between licensed schools, and satisfactory evidence of the above must be presented upon application.
