**Exam Statistics** 

Mr. Kirschner provided the Board with a report on exam pass rate comparison between the current exam vendor, Ergometrics/National Testing Network and a 2013 sample from the previous exam vendor, Professional Credential Services, Inc. Mr. Kirschner pointed out areas where scores have declined since the change in vendors. He also indicated that making exams available in multiple languages has impacted the waxing theory pass rates recently. Mr. Melis explained to the Board that, typically, there is a reduction in pass rates during the first year of a new exam administration. The Exam Pass Rate Comparison Report is included in these minutes as Addendum I.

Mr. Melis reported to the Board that Ergometrics/National Testing Network has put a new Program Manager in place and that DPOR would be paying particular attention to statistics and outcomes of the examinations. There will be considerable focus placed on a successful public school testing this spring, with a goal of conducting preparatory meetings across the state between the vendor, Board staff, and school administrators.

Report on Vendor

Mr. Kirschner reminded the Board that there are two sets of regulations currently in review, the Barber, Cosmetology, Nail Technician, and Wax Technician Regulations; and the Esthetic Regulations. Both sets of

regulations have been approved by the Executive Branch and a public comment period began on October 19, 2015 and is open until December 18, 2015. A public hearing will be conducted on December 16, 2015.

During the Executive Branch review, the Governor made two recommendations regarding (1) less restrictive criteria for criminal history application cases; and (2) facilities which may be out of compliance with new restroom regulations.

Mr. Kirschner reported to the Board on the Periodic Review of Public Participation Guidelines and Regulations and small business impact review, which is currently being conducted pursuant to the Governor's Executive Order 17.

Mr. Kirschner reviewed the results of the public comment period that took place from September 7, 2015 through September 28, 2015. Mr. Kirschner directed the Board to the Summary of public comments at the end of the Agenda. The Summary of public comments is included in these minutes as Addendum II.

The members voting 'yes' were Mr. R. Jones, Mr. T. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, Ms. Tsamouras, and Mr. Williams. There were no negative votes. The motion passed unanimously.

The Board discussed regulations pertaining to eyelash extensions and eyelashes. Ms. Tsamouras provided definitions of the different types of eyelashes, including (1) strip lashes; (2) bundle lashes; and (3) individual lash extensions. Ms. Tsamouras explained that strip lashes and bundle lashes are designed to last 12 to 24 hours; and lash extensions, which are applied to the natural lash with surgical grade glue, are expected to last 3 to 4 weeks.

answer questions about the different types of lashes and the training required for each type.

Ms. Peay asked that the Board consider that the Esthetic Regulations contain specific references to lashes and lash extensions.

After further discussion, and upon a motion by Ms. Tsamouras and seconded by Mr. R. Jones, the Board voted to provide its guidance that the exemption in Chapter 7. Barbers and Cosmetologists, § 54.1-701, for "persons whose activities are confined solely to applying make-up, including such activities that are ancillary to applying make-up" should be interpreted to pertain to strip and bundle eyelashes only.

The members voting 'yes' were Mr. R. Jones, Mr. T. Jones, Ms. LaPierre, Ms. McCaffrey, Ms. Tsamouras, and Mr. Williams. The members voting 'no' were Mr. Quesenberry and Mr. Minor. The motion passed by a majority.

The Board discussed the state requirement that applicants for licensure must provide a social security number or Virginia DMV control number to obtain a license, in light of the public comment regarding applicants completing training and sitting for the examination without being required to provide this same identification documentation. Mr. Melis noted that the application requires one of these two numbers, and any reference in the Candidate Information Bulletin to other identification notwithstanding, the application is clear. Mr. Melis stated staff would examine the Candidate Information Bulletin to ensure that the proper information is conveyed.
