Those with instructor licenses have not yet been issued due to an IT issue that is being worked on.

Mr. Melis advised the Board that House Bill 790, exempting persons working in a barber shop or cosmetology salon whose duties are confined to blow drying, cleansing, and styling hair from being required to obtain a license, was passed and will be effective July 1, 2018.

Mr. Melis and Mr. DeBoer further informed the Board of House Bill 883, a three-year Regulatory reduction pilot program through the Department of Planning and Budget, the goal of which is to reduce regulations and regulatory requirements by 25% in the Department of Professional and Occupational Regulation and the Department of Criminal Justice Services by July 1, 2021.

OLD BUSINESS

Tattooing and Body Piercing Regulations

Mr. Kirschner informed the Board that the NOIRA phase of the regulatory review of the tattooing and body piercing regulations was complete, and public comment had been received. In addition, a public meeting was held on March 12, 2018 to allow the public another opportunity for comment. Additional comments and feedback were obtained from a board member and staff, and the proposed regulations reflect the input from the public, board, and staff. Mr. Kirschner stated that the next step is for the Board to adopt the proposed regulations, after which the regulations will be submitted to the Executive Branch for its review.
