Mr. Bright and Ms. Taylor reported on their attendance at the National Committee of State Opticianry Regulatory Boards 2008 meeting held January 25-26, 2008 in Charleston, SC. A Task Analysis Survey for the development of a regional/national examination will be conducted. Other subjects discussed were challenges to state's examinations and licensure of opticianry businesses. **National Committee of State Opticianry Regulatory Boards**

The Board discussed the licensure in Virginia of opticianry businesses. Two primary concerns were businesses operating without licensed opticians and the selling of cosmetic contact lens. Staff provided to the Board the process for Board recommended legislation to be included in the Governor's legislative package. Also, noting that associations and individuals may work with their state delegates and senators to introduce legislation. **Legislation**

The Board discussed the development and conducting of the task analysis survey for opticianry. The Board reviewed the proposed survey and provided suggested revisions. Mr. Bright will make the revisions. **Task Analysis Survey**

The Board members reviewed their regulations for possible changes through regulatory review. Further discussion of regulatory review was carried over to a future meeting. **Regulations**

No other business was brought before the Board. **Other Board Business**




