A motion was made by Mr. Crouse and seconded by Mr. Northup to find no reasonable cause that the respondents discriminated in the terms, conditions and privileges or in services or facilities based on national origin. The motion passed by majority vote. Members voting "Yes" were: Bennett, Crouse, Howard, Lynch, Melton, Northup, Reisinger and Roth. Member voting "No" was Murphy.

In the matter of FHB File Number 2017-00010, Yolanda Viera Paz v. In the matter of FHB File Number 2017-00010, Yolanda Viera Paz v. Josh Bilder, Wayside Townhouse Apartments II, LLC, Sterling Management Corporation of Virginia, and Javier Echavarria, a motion was made Mr. Northup and seconded by Ms. Roth to find reasonable cause the respondents, Wayside Townhouse Apartments II, LLC and Sterling Management Corporation of Virginia, discriminated against complainant by refusing to renew her lease and forcing her removal thereby making housing unavailable to her based on her sex. The motion passed unanimously. Members voting "Yes" were: Bennett, Crouse, Howard, Lynch, Murphy, Northup, Reisinger and Roth. Melton abstained from voting in this matter.

A motion was made Mr. Northup and seconded by Ms. Roth to find reasonable cause the respondents, Wayside Townhouse Apartments II, LLC and Sterling Management Corporation of Virginia, discriminated against complainant by interfering with the complainant's fair housing rights to enjoy habitation in her apartment unit in a healthy and safe manner, and retaliated against her through non-renewal of lease and forced renewal on account of her having exercised her Fair Housing rights. The motion passed unanimously. Members voting "Yes" were: Bennett, Crouse, Howard, Lynch, Murphy, Northup, Reisinger and Roth. Melton abstained from voting in this matter.

A motion was made Mr. Crouse and seconded by Mr. Northup to find no reasonable cause the respondents, Josh Bilder and Javier Echavarria, in their individual capacities, discriminated against complainant by refusing to renew her lease and forcing her removal thereby making housing unavailable to her based on her sex or interfered with the complainant's fair housing rights to enjoy habitation in her apartment unit in a healthy and safe manner, and retaliated against her through non-renewal of lease and forced renewal on account of her having exercised her Fair Housing rights. The motion passed by majority vote. Members voting "Yes" were: Bennett, Crouse, Howard, Lynch, Northup, Reisinger and Roth. Member voting "No" was Murphy. abstained from voting in this matter.
