Finding a quorum of the Board present, Ms. Trigiani, Chair, called the Call to Order meeting to order at 9:35 a.m.

Ms. Henshaw advised the Board of amendments to the agenda. Mr. Approval of Agenda Orlando moved to approve the agenda as amended. Ms. Waddell seconded the motion which was unanimously approved by: Kacani, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts.

Mr. Orlando moved to approve the minutes as presented. Mr. Sterling seconded the motion which was unanimously approved by: Kacani. Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts.

Ms. Henshaw introduced to the Board staff member Ben Tyree, who was recently hired as a Licensing Specialist.

Introduction of Staff

There were no members of the public present to address the Board on matters other than case files to be presented.

**Public Comment Period** 

Ms. Kacani recused herself from the discussion of File Number 2017-01814.

Recusal of Board Member

In the matter of File Number 2017-01814, TheMVPService, LLC, the Board members reviewed the record which consisted of the Report of Findings, transcript and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. Mr. Haughwout advised the Board of a correction to the transcript wherein a statement made by Joseph Takacs, Jr. was incorrectly attributed to a DPOR staff member.

Joseph Takacs, Jr., President and Manager of TheMVPService, LLC, was present to address the Board. Mr. Takacs thanked the Board for their consideration and stated he was there to answer any questions for the Board regarding File Number 2017-01814.

After discussion, Mr. Watts moved to accept the Presiding Officer's recommendation and approve the time-share reseller registration application for TheMVPService, LLC. Ms. Waddell seconded the motion which was unanimously approved by: Johnson, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts.

Ms. Kacani returned to the meeting.

Return of Board Member

Mr. Haughwout asked the Board to consider issuance of a temporary cease and desist order against the project registration of North Drive Condominiums, for failure of the declarant, Hawkeye West, LLC, to submit an annual report as required by § 55-79.93 of the Code of Virginia, and Board Regulation 18 VAC 48-30-540. After discussion, Mr. Orlando moved to issue a temporary cease and desist order against the project registration of North Drive Condominiums, as violation of § 55-79.93 of the Code of Virginia, and Board Regulation 18 VAC 48-30-540 would cause irreparable harm to the public. Ms. Overholt seconded the motion. After further discussion, Mr. Orlando amended the motion and moved that North Drive Condominiums must come into compliance of all Board regulations and statutes within 30 days of the

issuance of the temporary cease and desist order to avoid further Board action. Ms. Overholt seconded the amended motion which was unanimously approved by: Johnson, Kacani, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts.

Mr. Haughwout asked the Board to consider issuance of a temporary cease and desist order against the project registration of Colonial Crossing, a Condominium, for failure of the declarant, Colonial Crossing, LLC, to submit an annual report and bond or letter of credit as required by § 55-79.93 of the Code of Virginia, and Board Regulation 18 VAC 48-30-540. After discussion, Mr. Orlando moved to issue a temporary cease and desist order against the project registration of Colonial Crossing, a Condominium, as violation of § 55-79.93 of the Code of Virginia, and Board Regulation 18 VAC 48-30-540 would cause irreparable harm to the public. Mr. Orlando further moved that Colonial Crossing, a Condominium, must come into compliance of all Board regulations and statutes within 30 days of the issuance of the temporary cease and desist order to avoid further Board action. Mr. Watts seconded the motion which was unanimously approved by: Johnson, Kacani, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts.

The Board recessed from 10:48 a.m. to 11:07 a.m.

Mr. Haughwout provided an update on the current status of the regulatory review processes for the Board's regulatory packages:

The final public comment period held on amendments to the Common Interest Community Ombudsman Regulations revising the timeframe for establishing a complaint process ended on April 19, 2017. There were no public comments received. Final regulations became effective on May 1, 2017.

Final amendments to the CIC Management Information Fund for a 2017 fee reduction became effective on May 17, 2017.

A final 30-day public comment period held on amendments to the training program provisions of the Common Interest Community Manager Regulations began on May 29, 2017, after which final regulations will become effective July 1, 2017.

A notice of intended regulatory amendment (NOIRA) for a general review of the CIC Management Information fund was published on June 12, 2017. A 30-day public comment period began on June 12, 2017 and will end July 12, 2017.

The Board considered for approval draft amendments to the POA Disclosure Packet Notice. After review and discussion of the draft amendments and the public comments received on the draft amendments, Mr. Watts moved to adopt the amendments to the POA Disclosure Packet Notice as presented. Mr. Orlando seconded the motion which was unanimously approved by: Johnson, Kacani, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts. The Board thanks all public commenters for their insights and participation in the review process.

Consider Adoption of Amendments for POA Disclosure Packet Notice

Mr. Haughwout presented to the Board for approval a draft of forms titled *Bond to Insure Escrow of Deposits* to be used by time-shares and time-share resellers when providing bond and/or letter of credit information for registration purposes as discussed at the March 13, 2017 Board meeting. Mr. Haughwout thanked Ms. Overholt for assisting Board staff with the development of the forms. The Board agreed by consensus to adopt the forms to be used for time-share and reseller registrations, effective immediately.

Bond Templates for Time-Share Registrations and Resellers

Ms. Henshaw presented to the Board for consideration a draft guidance document regarding exceptions to utilizing the association complaint procedure. Ms. Henshaw advised the Board that staff has received inquiries as to whether a complaint may be filed directly with the Board rather than through an association complaint procedure when the complaint is regarding disclosure packets or resale certificates in a real estate transaction. After lengthy discussion and review, the Board agreed by consensus to continue review of the draft guidance document later in the meeting.

Ms. Henshaw presented the Board with nine draft legislative proposals to be submitted for consideration during the 2018 General Assembly session.

2018 Legislative Items for Consideration

Mr. Watts asked the Board to consider the addition of an item #10. After discussion, Mr. Watts moved to include item #10 on the proposed list of legislative items to be submitted for consideration during the 2018 General Assembly session. Ms. Waddell seconded the motion which was approved by: Johnson, Kacani, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts. Mr. Orlando opposed the motion.

After further discussion and review of the draft legislative items, Mr. Sterling moved to approve the proposals for submission as amended with the addition of item #10. Mr. Orlando seconded the motion. After further discussion Mr. Sterling amended his motion to include a

modification of item #2. Mr. Orlando seconded, and the amended motion was unanimously approved by: Johnson, Kacani, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts. The Board agreed by consensus to authorize staff to make clerical and/or grammatical corrections.

Ms. Trigiani directed the Board's attention back to the guidance document regarding exceptions to utilizing the association complaint procedure for further review. After discussion, Ms. Overholt moved to not adopt the guidance document at this time and table the discussion on this subject until a later time. Mr. Watts seconded the motion which was unanimously approved by: Johnson, Kacani, Orlando, Overholt, Proctor, Sterling, Trigiani, Waddell, and Watts.
