#### MINUTES OF MEETING

Finding a quorum of the Board present, Ms. Trigiani, Chair, called the <u>Call to Order</u> meeting to order at 9:35 a.m.

Ms. Trigiani advised the Board of amendments to the agenda. Ms. Jonas moved to approve the agenda as amended. Mr. Mulhare seconded the motion which was unanimously approved by: Baker, Burrell, Jonas, Lockett Reese, Mulhare, Orlando, Overholt, and Trigiani.

Ms. Baker moved to approve the September 6, 2018, Board meeting minutes as presented. Ms. Overholt seconded the motion which was unanimously approved by: Baker, Burrell, Jonas, Lockett Reese, Mulhare, Orlando, Overholt, and Trigiani.

Approval of Minutes

Ms. Jonas moved to approve the September 27, 2018, CIC Management Information Fund Regulatory Review Committee meeting minutes as presented. Mr. Mulhare seconded the motion which was unanimously approved by: Baker, Burrell, Jonas, Lockett Reese, Mulhare, Orlando, Overholt, and Trigiani.

Cynthia Gale was present to address the Committee. Ms. Gale asked the Board to consider using the remaining interest accrued on the moneys in the CIC Management Information Fund to fund education programs for common interest communities as described in § 55-529 of the Code of Virginia. Ms. Gale also suggested that improvements be made to the license lookup feature on the DPOR website.

Public Comment Period

Mr. Sterling arrived at the meeting at 9:53 a.m.

Arrival of Board Member

Mr. Haughwout asked the Board to consider issuance of a temporary cease and desist order against the project registration of Oakwood Villas Condominium, for failure of the declarant, Oakwood Villa, LLC, to submit a complete annual report with evidence of a bond or letter of credit from a financial institution as required by § 55-79.93 of the Code of Virginia, and Board Regulation 18 VAC 48-30-540. Mr. Haughwout provided the following proposed language to include in the order: The declarant's failure to comply with § 55-79.93 of the Code of Virginia does not assure the public that the declarant is in compliance with the Condominium Act (§§ 55-79.39 et seq.) and the Board's Condominium Regulations, and would cause irreparable harm to the public interest.

Mr. Burrell moved to accept staff's proposed language and issue a temporary cease and desist order against the project registration of Oakwood Villas Condominium. Mr. Sterling seconded the motion. Discussion was held on the agency's procedure for sending solicitation letters requesting annual reports from declarants and follow-up procedures, as well as the Administrative Process Act. Discussion was also held on the procedure for transferring declarant control to an association and staff's process for documenting such transfer. Following discussion, the motion was unanimously approved by: Baker, Burrell, Jonas, Lockett Reese, Mulhare, Orlando, Overholt, Sterling, and

#### Trigiani.

Mr. Haughwout asked the Board to consider issuance of a temporary cease and desist order against the project registration of Old Heller Brothers Lofts Condominium, for failure of the declarant, Old Heller Brothers Lofts, LLC, to submit a complete annual report with evidence of a bond or letter of credit from a financial institution as required by § 55-79.93 of the Code of Virginia, and Board Regulation 18 VAC 48-30-540. Mr. Haughwout provided the following proposed language to include in the order: The declarant's failure to comply with § 55-79.93 of the Code of Virginia does not assure the public that the declarant is in compliance with the Condominium Act (§§ 55-79.39 et seq.) and the Board's Condominium Regulations, and would cause irreparable harm to the public interest.

Mr. Orlando moved to accept staff's proposed language and issue a temporary cease and desist order against the project registration of Old Heller Brothers Lofts Condominium. Ms. Overholt seconded the motion. After discussion, the motion was unanimously approved by: Baker, Burrell, Jonas, Lockett Reese, Mulhare, Orlando, Overholt, Sterling, and Trigiani.

Mr. Haughwout provided an update on the current status of the regulatory review processes for the Board's regulatory packages:

Update on Regulatory Review Process

The notice of intended regulatory action (NOIRA) for a general review of the CIC Management Information Fund Regulations was published in the Virginia Register on September 17, 2018. A public comment period was held from September 17, 2018 to October 17, 2018. No public comments were received. The CIC Management Information Fund Regulatory Review Committee met on September 27, 2018 to review the CIC Management Information Fund regulations. Draft amendments will be presented to the Board for consideration later in the meeting.

Amendments to the Time-Share Regulations as a result of HB674/SB443, which passed during the 2018 General Assembly session were published to the Virginia Register on November 12, 2018, and will become effective on December 14, 2018.

Ms. Henshaw presented the Board with draft amendments to the CIC Management Information Fund Regulations for review. After review and discussion, Mr. Orlando moved to authorize staff to file the amended draft as proposed regulations. In addition, Mr. Orlando further moved to authorize staff to make minor changes to the regulations, in consultation with the Board Chair, as necessary to allow the proposed

regulations to proceed through the review process. Mr. Sterling seconded the motion which was unanimously approved by: Baker, Burrell, Jonas, Lockett Reese, Mulhare, Orlando, Overholt, Sterling, and Trigiani.

Ms. Trigiani provided the Board with an update from the most recent meeting of the CIC Workgroup of the Virginia Housing Commission, held on October 18, 2018. Discussion was held on Senate Bill 706, Senate Bill 707, and House Bill 1041, all of which were considered during the 2018 General Assembly session, but did not pass to become law.

Ms. Henshaw and Ms. Trigiani reminded the Board that staff actively monitors legislation throughout each General Assembly session and provides data and information regarding the Board and Department relevant to legislative proposals affecting the Board. Ms. Gillespie provided the Board with a summary of the annual report on the Office of the Common Interest Community Ombudsman. The report contains statistics on complaints received by the Ombudsman's office, as well as compliance and enforcement statistics. Ms. Gillespie advised the Board the full report would be made available to them on upon final approval.

Ms. Henshaw provided the Board with the most recent financial statements and advised the Board that there have been no claims from the Recovery Fund.
