Ms. Nosbisch reported that at the June 20, 2018 meeting, the Board requested continuing education (CE) requirements for other certified professionals overseen by DPOR. Certified Interior Designers and Natural Gas Automobile Mechanics and Technicians are the other certified professions overseen by DPOR, and they do not require continuing education.

Continuing Education

At the June 20, 2018 meeting, Mr. Thomas stated he would conduct an independent survey of fellow geologists to inquire about their position regarding CE. At this time, Mr. Thomas has not had an opportunity to complete the survey.

Mr. Giannasi stated at the June 20, 2018 meeting that he would contact Virginia Association of Professional Soil Scientists (VAPSS) to request legislation to change the Board's regulations to eight continuing education hours per year. He stated VAPSS's next meeting is in October.

Ms. Nosbisch reported Mr. Thomas will be representing the Board at the ASBOG annual meeting in October. ASBOG is requesting annual meeting topics to be submitted for discussion at that meeting.

ASBOG Annual Meeting

ASBOG Exam Administration

Ms. Nosbisch reported that the Wetland Delineator proposed regulation prohibiting the use of work of another without written consent Fast Track is on the Governor's desk.

Regulatory Update

Discussion was held on HB 883, part of the red-tape regulatory reform, which directs DPB to administer a three-year regulatory reduction pilot program aimed at reducing by 25% the regulations and regulatory requirements, as defined in the bill, of the Department of Professional and Occupational Regulation and the Department of Criminal Justice Services by July 1, 2021. Ms. Nosbisch informed the Board a baseline of current regulations is to be established by October 1, 2018.

General Assembly Update

Board members were provided financial statements for informational purposes. Ms. Nosbisch noted that the Board is in a solid financial position.

Review of Financial Statements

As a quorum was not present for the meeting, and agenda items requiring Board action could not be addressed, the Board agreed by consensus to address the seven action items, including the licensing case, at a special meeting to be held on September 12, 2018 at 9:30 a.m.
