Ms. Henshaw advised the Board of the status of the Board's regulatory actions that are in process. Board-approved amendments to the regulations made pursuant to the Board's general review have been submitted for executive branch review. The final text is currently with the office of the Secretary of Commerce and Trade, and will then be submitted to the Governor's office. Following Governor approval, a final 30-day public comment period will be held prior to the amended regulations becoming effective.

**Update on

Processes**

The fast track action to amend public participation guidelines due to a statutory change is currently undergoing executive branch review. Following executive branch review, the amended public participation guidelines will be published in the Virginia Register, a 30-day public comment period will be held, and the amendments will become effective fifteen days after close of the public comment period.

Ms. Henshaw provided the Board a copy of the year-to-date examination statistics report for informational purposes.

**Examination  
Statistics Report**

Ms. Henshaw and Ms. Webster updated the Board on the waterworks and wastewater works national examination transition. Ms. Henshaw provided a sample diagnostic score report that will be available to waterworks and wastewater works license candidates immediately upon completion of the exam. Currently a score report is only available to candidates who do not pass the exam. The national exam vendor will provide this information for all candidates.

**Update on

The Board was provided with national exam vendor examination

materials for review. Discussion was held on whether Virginia-specific examination materials will be provided by the vendor.

Ms. Henshaw provided the Board with a license class exam equivalency chart, illustrating the national exam vendor equivalencies of waterworks and wastewater works license classes. Because the national exam vendor does not have an equivalent for a Class 6 Waterworks Operator license, Ms. Henshaw asked the Board to consider examination options. Discussion was held on the need for subject matter experts (SMEs) to take part in the selection of exam questions. After discussion, Mr. Staples moved to allow the national exam vendor to work with Virginia SMEs to customize an exam for the Class 6 Waterworks Operator license using the vendor's question bank. Mr. Fore seconded the motion which was unanimously approved by: Brockwell, Cooke, Evans, Ewing, Fore, Greene, Hammond, Lentz, Staples, and Wadkins. Mr. Fore volunteered to serve as an SME for the purpose of the development of the Class 6 Waterworks Operator license exam.

Discussion was held on the location of examination sites and reciprocity, as well as the need for delaying the Class 6 Waterworks Operator license exam for up to 30 days in order to allow time for selection of questions from the national exam vendor's item bank. The Board agreed by consensus to allow a 30 day delay to allow for the development of the Class 6 Waterworks Operator license exam.

Discussion was held on the timeframe in which a candidate who does not pass the exam may reschedule. After discussion, Mr. Fore moved to implement a 10-day waiting period from the day the examination is taken before allowing a candidate to reschedule the exam. Mr. Staples seconded the motion which was unanimously approved by: Brockwell, Cooke, Evans, Ewing, Fore, Greene, Hammond, Lentz, Staples, and Wadkins.

After further discussion on state-specific exam items and exam development, Ms. Webster advised the Board she would gather more information regarding the national exam vendor's question/item bank and physical examination locations.

Ms. Henshaw and Ms. Webster updated the Board on onsite licensing examination options. There is currently no viable national exam option for these licenses. Ms. Webster advised that staff is exploring alternatives to the current onsite licensing examination, and that staff is looking to maintain examination costs and locations similar to the current options.

The Board recessed from 10:03 a.m. to 10:18 a.m.

Ms. Henshaw provided an update on waterworks operator continuing professional education (CPE) audits. The audits were conducted on a random group of individuals making up 5% of the regulant population.




Mr. Hammond advised the Board that VDH is working to develop a waterworks school, and would provide more information as the project progresses.
