The sanctions reported by Ms. Laney were that Dr. Pollard shall be reprimanded and pay a \$3,000.00 monetary penalty. Within 6 months from the date of entry of the Order, Dr. Pollard shall successfully complete 7 credit hours in the subject of principles of pharmacology and prescription writing, and he shall not prescribe, administer, or dispense any Schedule II-IV drugs until he has successfully completed the course. Dr. Pollard shall also be subject to an unannounced records inspection within one year from the date of entry of the Order, to include a review of 5 patient records dated after November 1, 2013.

Dr. Rizkalla moved to adopt the decision of the Committee. The motion was seconded and passed.
