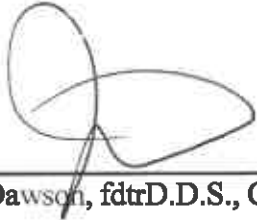
Dr. Bryant moved to adopt the decision of the Committee. The motion was seconded and passed.
