Within 6 months from the date of entry of the Order, Dr. Rader shall successfully complete the following continuing education courses: 6 hours in the subject of diagnosis and treatment planning; 4 hours in the subject of radiographic interpretation; 3 hours in the subject of dental recordkeeping; 3 hours in the subject of oral surgery complications; 2 hours in the subject of restorative procedures of endodontically treated teeth; and 2 hours in endodontic rotary instrumentation.

Mr. Martinez de Andino moved to adopt the decision of the Committee. The motion was seconded and passed.
