James W. Holley, IV., D.D.S. Case Nos.: 197668 and 200070

Dr. Holley appeared with counsel, Nora T. Ciancio, to discuss the allegations set forth in a Notice of the Board dated November 4, 2021. Patient C was present at the informal conference. The Committee received statements from Dr. Holley, Ms. Ciancio, and Patient C and discussed the allegations with them.

Closed Meeting:

Dr. Chaudhry moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of James Holley. Additionally, Dr. Chaudhry moved that Ms. Sacksteder and Ms. Lee attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Committee in its deliberations. The motion was seconded and passed.

Reconvene:

Dr. Chaudhry moved that the Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and passed.

DECISION:

Case Nos.: 197668 and 200070

The sanctions reported by Ms. Sacksteder were that Dr. Holley was issued a reprimand and shall pay a \$15,500 monetary penalty.

Dr. Holley was also placed on probation for a period of not less than two years subject to the following terms and conditions: Within 6 months from the date of entry of the Order, Dr. Holley shall complete a 7 hour continuing education course in the subject of dental recordkeeping; 4 hour continuing education course in the subject of radiographic diagnosis; and a 7 hour continuing education course in the subject of crown and prep placement procedures.

Dr. Holley is restricted from performing crown and prep placement procedures until he has completed the 7 hour continuing education course in the subject of crown and prep placement procedures.

Dr. Holley is restricted from performing sedation or endodontic procedures for a period of not less than two years from the date of entry of the Order. Dr. Holly is also subject two unannounced patient records audits.

Dr. Chaudhry moved to adopt the decision of the Committee. The motion was seconded and passed.

Approval of Minutes:

Upon a motion by Dr. Butt, the minutes from the Informal Conference conducted on January 31, 2022 were approved.
