Additionally, she moved that Board staff, Ms. Sacksteder, Ms. Weaver, Ms. Lee, Ms. Moore, and Board counsel, Mr. Rutkowski; Mr. Ortega, Mr. Murphy, Ms. Smith, Ms. Ciancio, Mr. Goodman, and Mr. Smith attend the closed meeting because their presence in the closed meeting was deemed necessary and their presence will aid the Board in its deliberations. The motion was seconded and passed.

Mr. Murphy and Ms. Ciancio provided closing statements.

#### Reconvene:
