CALL TO ORDER: A Special Conference Committee of the Board was called to order at 9:06 a.m.

The Committee fully discussed the allegations in the Notice with Dr. Liu.

CLOSED SESSION: Upon a motion by Dr. Rambhia, and duly seconded by Ms. Hickey, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Liu. Additionally, she moved that Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.

RECONVENE: Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.

DECISION: Upon a motion by Ms. Hickey, and duly seconded by Dr. Rambhia, the Committee voted to exonerate Dr. Liu.

VOTE: The vote was unanimous.

ADJOURNMENT: The Committee adjourned at 10:31 a.m.




Ms. McNicol advised that the Notice had been sent to Dr. King's address of record with the Board by overnight and First class mail.
