deliberation to reach a decision in the matter of Mr. Greathead. Additionally, he moved that Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee

in its deliberations.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code,

the Committee re-convened in open session and announced its

decision.

Upon a motion by Dr. Elariny, and duly seconded by Mr. Bell, the Committee made certain findings of fact and conclusions of law and voted to reinstate Mr. Greathead's license contingent upon completing certain terms and conditions.

Upon such timely request for a formal hearing, the decision of the Special Conference Committee shall be vacated.
