NEW BUSINESS:

Dudley Harris for John Biagas, Chairman of the Exemption from Examination subcommittee – Sponsor number 2001-017R, an active sponsor in Virginia since 1971. The number of related instruction hours per year is above the minimum requirement and the on-the-job learning hours are 10,000. This sponsor has met all the requirements set by the council for exemption from licensing examination. Approval recommended until April 30, 2017.

Note: This date brings all approved sponsors into the same expiration date for the year of 2017.

A motion was properly made and seconded and it was passed by roll call vote.

75th Anniversary Of The Signing Of The Virginia Apprenticeship Act Celebration

Bev Donati, Director of the Division of Registered Apprenticeship welcomed all and began the celebration with further introductions. Ms. Donati mentioned that Henry Dowdy, age 98, the very first to receive a Certificate of Completion from the Virginia Department of Labor and Industry was unable to attend due to a recent health issues. A picture on display will be presented to him during his recuperation period.

Recognition of Mr. Robert F. Beard, Former Commissioner:

Daughter, Ms. Kim Kacani spoke on the behalf of her father, Robert Beard, who was in attendance. She reminisced about her father's past as an apprentice and his time spent as Commissioner of the Virginia Department of Labor and Industry. A framed picture was presented .

Introduction of Secretary James S. Cheng:

Assistant Commissioner, Bill Burge introduced Secretary Cheng. Secretary Cheng spoke about the importance of registered apprenticeship. He ended by reading a Certificate of Recognition from Governor McDonnell. The Certificate was presented to Mr. Burge and Mr. Kemp. Mr. Burge presented a Certificate of Appreciation to Secretary Cheng.

Introduction of Former Apprentices:

Chairman Kemp introduced two graduates of apprenticeship, Mr. Mac Beaton, Director Career & Technical Education, Henrico County Public Schools and Mr. Everett Jordan, Director of Education, The Apprentice School. Each spoke about what registered apprenticeship has meant in their lives. Mr. Kemp presented a Certificate of Appreciation to each.

President Norris Williams, Virginia Apprenticeship Alumni Association:

Ms. Donati introduced Mr. Williams. Mr. Williams first introduced the Board of Directors for the VAAA and proceeded with introducing Dr. James Hughes.

Dr. James Hughes, Manager of Training, The Apprentice School:

Dr. Hughes gave the history of when and how the Virginia Apprenticeship Alumni Association began and how it seeks to be a positive force in telling others the value of apprenticeship and providing scholarships to graduate apprentices and career and technical secondary teachers.
