**DISCUSSION:** The Board received evidence and sworn testimony from witnesses called to testify regarding the allegations in the Notice and Statement of Particulars dated November 24, 2009.

**PRELIMINARY  
MATTERS:**

The Chair noted that Ms. Bailey was not present. Mr. Opper presented Commonwealth's Exhibit #1, the notice of hearing and affidavit signed by the Executive Director for the Board attesting that notice had been sent to Ms. Bailey's address of record. Mr. Opper also presented Commonwealth's Exhibit #5, a letter from Ms. Bailey stating that she would not be present at the hearing.

**RULING:**

The Chair ruled that proper notice had been given to Ms. Bailey regarding the proceeding; therefore, the hearing would proceed in her absence. Commonwealth's Exhibits #1 and #5 were admitted into evidence.

**CLOSED SESSION:**

Upon a motion by Dr. Clark and duly seconded by Dr. Kuley, the Board voted to convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Rebecca Bailey. Additionally, he moved that Mr. Casway, Patricia Larimer, and Debbie Harris attend the closed meeting, because their presence in the closed meeting was deemed necessary and would aid the Board in its deliberations.

**RECONVENE:**

Having certified that the matters discussed in the preceding closed session met the requirements of § 2.2-3712 of the Code, the Board reconvened in open session and announced its decision.

**DECISION:**


Upon a motion by Dr. Clark, and duly seconded by Dr. Stewart, the Board made certain Findings of Fact and Conclusions of Law. Further, upon a motion by Dr. Clark, and duly seconded by Dr. Kuley, the Board voted to revoke Ms. Bailey's certification to practice as a Sex Offender Treatment Provider in Virginia. The vote was unanimous.
