Mr. Linkous, Chair, called the meeting to order at 10:00 a.m.

Call to Order

Mr. Linkous advised the Board of the emergency evacuation procedures.

Emergency Evacuation Procedures

Ms. Terry moved to approve the agenda. Mr. Lee seconded the motion which was unanimously approved by members: Lee, Linkous and Terry.

Approval of Agenda

Mr. Lee moved to approve the July 22, 2015, Board meeting minutes. Ms. Terry seconded the motion which was unanimously approved by members: Lee, Linkous and Terry.

Approval of Minutes

Public Comment Period – There were no public comments.

Public Comment Period

Ms. Nosbisch welcomed and introduced audience member Laura Farley, Virginia Association of Realtors. Ms. Nosbisch also introduced staff members in the audience, Joseph Haughwout and Susan Garbini.

Regarding File Number 2015-00614, Daniel Jarrod Hines, the Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigative file, transcript and exhibits, the Summary of the Informal Fact-Finding Conference, and the presiding Board member's recommendation. Ms. Terry moved to accept the recommendation of the presiding Board member that the file be closed with a finding of no violation. Mr. Lee seconded the motion which was

unanimously approved by members: Lee, Linkous, and Terry. Former Board member Samuel Updike was the presiding officer.

Regarding File Number 2015-00697, Ralph Edward Weese, Board members reviewed the Consent Order as seen and agreed to by Mr. Weese. Ms. Terry moved to accept the Consent Order which cites the following violations of the Board's regulations: 18VAC25-21-110.A.2 (Count 1); and 18VAC25-21-110.A.7 (Count 2); 18VAC25-21-110.A.8 (Count 3); 18VAC25-21-110.B (Count 4); 18VAC25-21-110.A.1.a (Count 5); 18VAC25-21-110.A.5 (Count 6); 18VAC25-21-150.D (Count 7); 18VAC25-21-180.5 (Count 8); and 18VAC25-21-180.4 (Count 9). For these violations, Mr. Weese agrees to the following sanctions: \$500 for the violation contained in Count 1: \$500 for the violation contained in Count 2: \$500 for the violation contained in Count 3; \$250 for the violation contained in Count 4; \$1,000 for the violation contained in Count 5; \$100 for the violation contained in Count 6; \$500 for the violation contained in Count 7; \$1,000 for the violation contained in Count 8; \$500 for the violation contained in Count 9; and \$150 in Board costs, for a total monetary penalty of \$5,000.

File Number 2015-00697, Ralph Edward Weese

The Board shall waive imposition of the \$500 monetary penalty for Count 1 provided Mr. Weese provides a copy of his current contract within thirty (30) days of the effective date of this Order. The contract must be in compliance with Board Regulation 18 VAC 25-21-110.2. If Mr. Weese fails to comply with this condition, then the full monetary penalty will be automatically imposed.

Further, the Board shall waive imposition of the \$500 monetary penalty for Count 2 provided Mr. Weese provides a copy of his current contract within thirty (30) days of the effective date of this Order. The contract must be in compliance with Board Regulation 18 VAC 25-21-110.A.7. If Mr. Weese fails to comply with this condition, then the full monetary penalty will be automatically imposed.

In addition, the Board shall waive imposition of the \$500 monetary penalty for Count 3 provided Mr. Weese provides a copy of his current contract within thirty (30) days of the effective date of this Order. The contract must be in compliance with Board Regulation 18 VAC 25-21-110.A.8. If Mr. Weese fails to comply with this condition, then the full monetary penalty will be automatically imposed.

Lastly, the Board shall waive imposition of the \$1,000 monetary penalty for Count 8.

Mr. Lee seconded the motion which was unanimously approved by members: Lee, Linkous and Terry. The presiding board member, Mr. Farmer was not present for the meeting.

Ms. Nosbisch informed the Board that the new regulations become effective November 1, 2015. The regulations contain language regarding acceptance of continuing education from states which Virginia has reciprocal licensing agreements, provided those states will accept Virginia continuing education. Ms. Nosbisch reported that Virginia has reciprocal licensing agreements with 14 states.

Regulatory Update

Mr. Linkous inquired as to whether any states had terminated reciprocal agreement with Virginia due to the regulations not being comparable. He further commented that the implementation of continuing education was due to the need to make Virginia regulations comparable to surrounding states. Ms. Nosbisch stated that she would research the matter and provide information to the Board.

Ms. Nosbisch further informed the Board that a periodic review would be held on the regulations, the public comment period will be open December 14, 2015 – January 4, 2016. The Board will review any comments received at the January 13, 2016 Board meeting. Ms. Nosbisch stated that the issue of internet auctions could be discussed during the periodic review process. She further commented that if any changes to the regulations were needed, a Notice of Intended Regulatory Action would be filed. Mr. Courtney stated that the periodic review is mandated every four years to ensure the regulations are current and up to date, adding that the impact on small businesses is also reviewed. Discussion was held on the public comment process.

Mr. Phillips arrived at 10:14 a.m.

Arrival of Board Member

Further discussion was held on the issue of internet auctions. Ms. Peay commented that internet auctions would be difficult to regulate due to the vastness of the internet and sheer volume of online auctions.

Regulatory Update

Ms. Nosbisch reported that letters for the continuing education audit were mailed September 22, 2015, to 69 randomly selected licensees, with responses due October 15, 2015 (21 days). Ms. Nosbisch informed the Board that 50 licensees had responded and that final results would be provided at the next Board meeting.

Continuing Education Audit

Board members were provided a comprehensive report of enforcement activity for informational purposes.

Review of Compliance and Investigations Division Activity

Board members were provided financial statements for informational purposes.
