There is also one existing auctioneer vacancy. Ms. Nosbisch has been in communication with the office of the Secretary of the Commonwealth regarding appointments.

Ms. Nosbisch reported that in the next few months, the Board members will be receiving noncompliant continuing education cases. Mr. DeBoer inquired if anyone had requested a continuing education waiver. Ms. Nosbisch stated none had been requested.

Ms. Terry noted that on the DPOR website when using the License Lookup, the license results list does not show current or expired on the first screen. You must click on the license number and read that following Auctioneers Board Meeting Minutes October 12, 2017 Page 4 of 4

page to determine if the license is up to date. She noted that the general public may assume that the list brings up all that are current. It would be helpful if the list of licenses show whether they are current or expired instead of having to go to the next page.
