

THE VIRGINIA BOARD OF ACCOUNTANCY
Enforcement Committee
Meeting Minutes
June 3, 2008

The Virginia Board of Accountancy's Enforcement Committee met on Tuesday, June 3, 2008, at 9960 Mayland Drive, Perimeter Center, Second Floor Conference Center,, Hearing Room 2, Richmond, Virginia 23233

There were no members of the public in attendance

The meeting convened at 9:45 a.m.

The Enforcement Committee opened the meeting with respect to Agenda Item A, and agreed unanimously that all actions taken by the Board should be posted on the Board's website. With respect to Agenda Item B, it was determined that additional information was required from a NASBA representative in order to provide the Board with a recommendation and was therefore deferred until the next Enforcement Committee meeting. With respect to Agenda item C, the review of open disciplinary cases was discussed in closed session.

Upon a motion by Ms. Calderone, and seconded by Mr. Dickerson, the Committee approved by unanimous vote that the meeting be recessed and that the Committee immediately reconvene in closed session for the purpose of consultation on Committee matters within the jurisdiction of the Board as permitted by § **2.2-3711 A.28** of the *Code of Virginia*.
