The Virginia Board of Accountancy's Enforcement Committee met on Wednesday, August 24, 2011, at 9960 Mayland Drive, Perimeter Center, 2nd Floor Commonwealth Conference Center in Hearing Room 2, located in Henrico, Virginia 23233.


Upon a motion by Ms. Kilmer and seconded by Ms. Calderone, the Committee voted to take action, as follows:
