

VIRGINIA BOARD OF ACCOUNTANCY
Enforcement Committee Meeting Minutes
April 26, 2017

The Virginia Board of Accountancy's Enforcement Committee met on Wednesday, April 26, 2017, at 9960 Mayland Drive, Perimeter Center Building, in the Commonwealth Conference Center's Board Room 3, located in Henrico, Virginia 23233.

The meeting convened at 9:00 A.M.

The Enforcement Committee called to order the meeting with respect to Agenda Item A. No public comment was received with respect to Agenda Item B. With respect to Agenda Item C through G, the Presiding Officer and Committee member reviewed the Informal Fact-Finding case referenced herein as files 2017-077-005E, 2016-CPE-0058, 2016-CPE-0055, 2016-CPE-0080, and 2017-032-014C.

Upon completion of the Informal Fact-Finding cases, the Presiding Officer, with respect to Agenda Item H, review of open cases, suggested that the Committee go immediately into closed session.

Upon a motion by Mr. Jewell, and seconded by Ms. Allen, the Committee approved by unanimous vote that the meeting be recessed and that the Committee immediately reconvene in closed session for the purpose of consultation on Committee matters within the jurisdiction of the Board as permitted by Code of Virginia § 2.2-3711(A)(28).
