#### PROFESSIONAL ENGINEERS SECTION MEETING

#### MINUTES

The Professional Engineers Section of the Virginia Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects (APELSCIDLA Board) met on November 14, 2012, at the Department of Professional and Occupational Regulation, 9960 Mayland Drive, Richmond, Virginia, with the following members present:

No representative was present from the Office of the Attorney General.

Mr. Combs, Chair, called the meeting to order at 9:05 a.m.

Mr. Combs reviewed the emergency evacuation procedures.

Mr. Johnson moved to approve the agenda as amended. Ms. Langelotti seconded the motion which was unanimously approved by members: Combs, Johnson and Langelotti.

There was no public comment.

Ms. Nosbisch explained to the section that Mr. Smith's case was previsouly reviewed at the September 28, 2011, APELSCIDLA Board meeting. The Board voted to remand the case back to an IFF to obtain more information.

Regarding **File Number 2011-00683, Russell Ross Smith**, the Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigation, transcripts, exhibits, and the Summary of the Informal Fact-Finding Conference as well as the recommendation of the presiding board member. Mr. Johnson recommended that the Board accept the Summary of the Informal Fact-Finding Conference which cites the following violations of the Board's regulations: 18VAC10-20-740.D (Count 1); 18VAC10-20-730.C (Count 2); 18VAC10-20-740.C (Count 3); 18VAC10-20-700.A (Count 4); and 18VAC10-20-760.B.3 (Count 5). Langelotti seconded the motion which was unanimously approved by members: Combs, Johnson and Langelotti.

Ms. Clay informed the section that Mr. Smith had no prior violations. Mr. Johnson moved to recommend that the Board accept the recommended sanctions as contained in the Summary of the Informal Fact-Finding Conference: \$500 for the violation contained in Count 1; \$2,500 for the violation contained in Count 2; \$2,500 for the violation contained in Count 3; \$2,500 for the violation contained in Count 4; \$500 for the violation contained in Count 5; and revocation of license, for a total monetary penalty of \$8,500 and revocation of license. Ms. Langelotti seconded the motion which was unanimously approved by members: Combs, Johnson and Langelotti.

Ms. Nancy McIntyre, Land Surveyor and APELSCIDLA Board member, was the presiding officer.

Section members reviewed correspondence from Mr. Chuck Dunlap, LSB, and the Virginia Department of Health (VDH) regarding the need for a PE seal and signature on surveys that include a septic field. The PE Section agreed by consensus that according to the Board's regulations, a PE seal is required. Ms. Nosbisch stated that the Land Surveyor Section would be discussing the issue at their meeting, November 15, and that Mr. Dunlap would be attending the meeting. Ms. Nosbisch will provide the LS Section with the PE recommendation.

Discussion on PE Plans on Survey Plats

Mr. Garofalo reviewed procedures used by the licensing staff when assessing EIT and PE applications.

Discussion on Application Review Process

Mr. Dixon discussed the volume of applications that are reviewed by the PE Section. As Professional Engineers represent 70% of the APELSCIDLA Board's regulants, the PEs review many more applications than the other professions. Mr. Dixon asked Section members to consider options to streamline the process. Discussion was held on various options such as adding an additional PE seat on the Board; an advisory group with more diverse expertise to review applications, providing more depth in subject matter expertise; or to leave as is.

Mr. Johnson stated that although the PEs have a large volume of applications to review, the licensing staff does a great job organizing the application packages, which in turn makes the review process flow smoothly. Mr. Johnson agreed that the application review process could benefit from a more diverse field of experts.

Mr. Dixon informed the Section that the Real Estate Board utilizes subcommittees for various issues. He further commented that should an advisory group be implemented, members could be a pool from which future Professional Engineers Section Meeting Minutes November 14, 2012 Page 3 of 4

board members could be selected, as they would be knowledgeable about Board processes and procedures. Mr. Dixon informed section members that approximately 10 years ago, a task force was created to address this issue, the task force decided not to add an additional PE member to the Board. He further stated that board member Bob Boynton, who previously served on the APELSCIDLA Board, was a member of the task force and that perhaps Mr. Boynton could provide historical background on the issue.

Mr. Combs recommended inviting Mr. Boynton to the next section meeting for input, and also suggested inviting former board member Stanley Harris, PE. Ms. Nosbisch will extend invitations to the February 6, 2013, section meeting. Mr. Combs will inform the full Board at its December 13, meeting, that the Section is considering options designed to lessen the application review workload.

The Section agreed by consensus to consider options for discussion at the February 6, 2013, section meeting.

Ms. Nosbisch reported that the Board received correspondence from the South Carolina Board of Professional Engineers and Surveyors announcing Miller L. Love's candidacy for NCEES Southern Zone Vice-President. This is the first correspondence received since the Board's transfer from the Northeast Zone to the Southern Zone.

Mr. Johnson reported that the NCEES Committee on Examinations for Professional. Engineers (EPE), of which he is a member, met in Atlanta in September and will be meeting again January 18-19, in Clemson, SC.

Ms. Nosbisch informed the Section that the first software engineering exam would be administered this Spring. Ms. Nosbisch acknowledged that there have been discussions with other states regarding concerns with the exam and Standard of Practice and how to validate experience. The Section agreed by consensus that, as is our standard practice, we do not license by discipline, individuals choose to sit for any of the engineering exams offered and applications would be reviewed on a case-by-case basis for related experience

Ms. Nosbisch informed the Section that former board member, Stanley Harris, PE, was recognized in the Richmond Times Dispatch for receiving the NCEES Distinguished Service Award with Special Commendation.

Ms. Nosbisch also informed the Section that the proposed board regulations continue to be in the review stage by the Governor's office. She further explained the Governor's Reform Initiative on regulations. Governor McDonnell has asked all agencies to conduct a review of all regulations to eliminate unnecessary or burdensome regulations. The public comment period ends December 5.

DHCD is preparing to revise their information, and have asked for input from the Board. Ms. Nosbisch stated the chart may need to be updated and will be asking for review by an architect and PE representative.
