Jeff Waite, Financial Services Director, provided information on proposed fee increases, allocation of expenses and adjustments for sufficient revenue. Mr. Waite explained that no fee increase was to be made at this time, but that approval was needed for when the increase needed to be implemented. He presented three proposals for consideration: 1) New application fee and renewal fee are equal; 2) New application fees higher than renewal fee; 3) New application fees lower than renewal, allowing the cost of entry into profession to be lower.

Discussion was held on the three proposals. Ms. Price moved to accept the third proposal of lower fees for new application to allow the cost of entry into profession be lower. Mr. Boynton seconded the motion which was unanimously approved by members: Allen, Anglin, Boynton, Kelly, Nair, Price, Reynes, Stiles, Stokes, and Zmuda.

Board financial statements were provided for informational purposes. Mr. Zmuda inquired about any changes in financials due to COVID-19. Mr. Waite stated that new applications decreased in March and April, but have rebounded to almost normal levels in May and June,

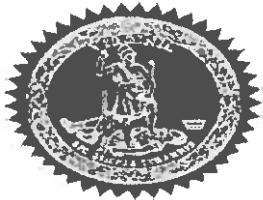
WHEREAS, the mission of the APELSCIDLA Board for the past 100 years has been to protect the health, safety, and welfare of the citizens of the Commonwealth; and
