#### Comments from the Commissioner – Duke Storen

Commissioner Storen extended his appreciation to the members of the Board, colleagues of the public, local departments and staff for attending the meeting.

The Commissioner provided federal and state updates.

J.R. Simpson, Chief Deputy Commissioner, provided updates on the federal and state budget.

The Commissioner shared J.R. Simpson's retirement announcement and thanked him for his tremendous public service.

**Medicaid Expansion** – In Toni Washington's absence, Linda Nablo, Special Advisor to the Office of the Governor, gave a presentation on Medicaid expansion. Handouts were provided.

**2-1-1 Virginia Outreach** – Fran Inge, Director of the Division of Volunteer and Community Services, provided background on her division and introduced Gail Harris, Director of Office On Volunteerism and Community Service. Ms. Harris gave a presentation on 2-1-1 Virginia Outreach and provided handouts.

## **CLOSED MEETING**

**On Motion Duly Made**, (Ms. Boyd), second (Mr. Boone)-moved to go into a closed meeting for the purpose of receiving additional information and legal advice regarding the investigation of Ronald Scearce, member of the Pittsylvania local board of social services, pursuant to Virginia Code § 2.2-3711A.1.7. Ms. Hulcher expressed her support of the amended change of first aid CPR. She requested a 90-day certification window to get staff properly trained and to continue to allow teachers under the age of 18 to work alone.

#### **Grace Creasey – Virginia Council for Private Education**

Ms. Creasey thanked the Board for the regulations regarding the first aid and CPR requirements.

There were no comments from boards and directors of community action agencies.

### Comment from Virginia Community Action Partnership – Jim Schuyler

Mr. Schuyler gave an advance look at some of the stories to be included in his annual report. He spoke about the SwiftStart program and People Incorporated of Virginia Whole Family Approach.

## **Comment from Virginia League of Social Services Executives**

Andy Crawford – League President & Director of Bedford Department of Social Services

Mr. Crawford echoed that Medicaid expansion is going fairly well. He talked about the JLARC study and expressed interest in offering to help make the system better.

# Pittsylvania Department of Social Services Investigation – Ellen Malenke

**On Motion Duly Made**, (Ms. Ali), second (Ms. Boyd), motion to suspend Mr. Scearce pending additional investigation. After further discussion, Ms. Ali offered an amended motion to suspend Mr. Scearce until the next Board meeting (2/20/2019). Ms. Washington provided a second to that amended motion. Motion approved with six in favor (Ali, Heck, Boyd, Washington, Malik, Brennan) and three opposed (Kines, Santana, Boone).

Ms. Malenke will draft a letter to Mr. Scearce, with copies to the Pittsylvania County Board of Supervisors and the local board of social services, documenting the vote on this item.

Ms. Boyd asked members for closing comments and suggestions for future meeting topics. Members provided reflective comments on the meeting in general. Suggested agenda items: continue to monitor co-op schools; updates on high profile assisted living cases; follow up on board training; and progress on recommendations on Rockbridge County.
