Comments from the Commissioner – Acting Commissioner Williams provided local, state, and federal updates.

Comment from the VA Community Action Partnership – Erik Johnston, Executive Director Mr. Johnston thanked Acting Commissioner Williams for meeting with the executive committee and he appreciates the partnership with the Community Action. He also thanked Rebecca Morgan and the League of Social Services. The Community Action had great regional meetings where for the first time the Community Action and local departments came together with some of the small peer groups on the match saving program. He thanked the Governor and the general assembly on the volunteer income tax assistance program. He shared that the whole family two generation pilot continues in the two-year biennium. The Community Action hopes to have the opportunity with Virginia Energy and the home rebate programs.

Comment from the Virginia League of Social Service Executives — Rebecca Morgan, President Ms. Morgan shared the League is excited about the training academy and hope that are renovations going on and hope to give a tour at some point. They are busy partnering with VDSS on implementing the kinship bill that was unanimously passed by the general assembly. The League is working with BPRO to hold a legislative advocacy event at VDSS. At the July board meeting, the League will focus on recruitment and retention. They've partnered with VDSS to secure funding to contract with a marketing firm.
