Prior to the vote on the amended Six Year Plan Resolution Mr. McCarthy shared that there is a little bit of confusion that involved himself, the Chairman and Director Drake over the last month or so regarding the program the CTB approved for the Norfolk Train Service through Richmond and to points north having to do in summary with a state project and a federal project.

Because there has been some misunderstanding and hard feelings and to be clear and consistent with what the CTB approved back in February and what the CTB is in fact actually going to do, Mr. McCarthy indicated he would introduce a resolution in July to clarify exactly what the CTB is trying to do with the Norfolk Service, the High Speed Rail Service and how that affects Richmond and when it all goes through Main Street Station.

The resolution will reiterate that the CTB is 100% behind the Norfolk Service, reaffirm the CTB commitment to High Speed Rail through Main Street Station including eventually the Norfolk Train.
