The final VPDES General Permit Regulation for Industrial Activity Storm Water Discharges (9 VAC 25-151) was adopted by the State Water Control Board in March, 2004. Subsequent to that adoption, and after publication of the final document in the Virginia Register, several errors and omissions were discovered in the regulation. The following corrections are being made:

- 1. Table 140 (Sector F): Insert the parameter "Total Recoverable Zinc" with a monitoring cutoff value of "120 ug/l" into the "Rolling, Drawing, and Extruding of Nonferrous Metals (SIC 3351-3357)" monitoring category.
- 2. Table 150-1 (Sector G): Typo in the "Total Suspended Solids" monitoring cutoff value for the "Active Copper Ore Mining and Dressing Facilities (SIC 1021)" monitoring category. The value should be 100 mg/l, not 100 ug/l.

- 3. Section 9 VAC 25-151-160 (Sector H): Typo in subsection C 2 b. "premittee" should be "permittee".
- 4. Table 180-2 (Sector K): Two typos in the last monitoring parameter. Should be "Total Recoverable Silver", not "Recoverable Silver", with a monitoring cutoff value of "4.1 ug/l", not "4.1 ug".

- 5. Section 9 VAC 25-151-230 (Sector P): Typo in subsection B 3 a (1). "torage" should be "storage".
- Table 280 (Sector U): Insert the parameter "Total Suspended Solids (TSS)" with a monitoring cutoff value of "100 mg/l" into the "Grain Mill Products (SIC 2041-2048)" monitoring category.

Both of the parameters that were omitted, and all of the typos in the tables were in and correct in the previous industrial general permit regulation, and are in EPA's Multi-sector Industrial General Permit, which was the basis for this general permit regulation.
