The Virginia Employment Commission (VEC) seeks to amend Sections 10, 20, and 30 of 16 VAC 5-60 to clarify current practices, update language to conform to current policies, update UI form names/titles and eliminate requirements already addressed by statute. This action will remove obsolete language from 16 VAC 5-60-10 subsection C and remove language that is already addressed by statute from subsection E.

16 VAC 5-60-20 is amended to remove language that is no longer relevant to UI processes or rules that are duplicative or already established UI claim filing rules. The language is also being amended to update names of forms to be in plain language.

16 VAC 5-60-30 is amended to remove duplicative language.

FORMS will be changed to update a form name. No changes will be made to the content of the form.

Acronyms and Definitions

"VEC" means Virginia Employment Commission. "Commission" means Virginia Employment Commission. "UI" refers to unemployment insurance.

On June 28, 2024, the Commissioner approved amending 16 VAC 5-60, Total and part-total unemployment, Partial Unemployment, and Disposition of benefit checks payable to a deceased claimant. The action is being taken by the Virginia Employment Commission and regulation title is 16. Labor And Employment.

Mandate and Impetus

Executive Order 19 requires agencies to modernize and eliminate unnecessary regulations. As part of this process, VEC determined amendments were needed for 16 VAC 5-60 to reflect an updated and more accurate layout of the UI process.

The Virginia Employment Commission is the promulgating agency. The VEC may promulgate these regulations pursuant to §60.2-111 of the Code of Virginia.

Removal of the language makes the regulations less burdensome.

There are no new provisions added to the regulation.

The advantage to both the public and the agency is the regulations will now conform to the current practices of the UI division and remove language already addressed by statute or prior regulation, to reduce the overall regulatory burden. There is no disadvantage as no changes in the UI process will occur because of the updates.
