Tradesman courses must be completed through accredited colleges, universities, junior and community colleges, adult distributive, marketing and formal vocational training as defined in this chapter; Virginia Apprenticeship Council programs or proprietary schools approved by the Virginia Department of Education.

B. Backflow prevention device worker courses must be completed through schools approved by the Board for Contractors. The Board for Contractors accepts the American Society of Sanitary Engineers (ASSE) standards for testing procedures (other programs could be approved after board review) and requires all backflow training to include instruction in a wet lab.
