- 1) The public comment period for the Periodic Review related to 6VAC 40-40 closed on September 4, 2012 without comment from any member of the public.
- 2) These regulations detail the procedure for collecting DNA samples from individuals arrested for violent felonies and certain burglaries as required by Virginia Code §19.2-310.2;1 and 19.2-310.3:1. DNA samples collected and analyzed pursuant to these Code Sections are included in the Virginia DNA data bank. "Hits" between known profiles and crime scene samples are reported to law enforcement agencies to assist their efforts to solve crimes committed in Virginia. To the extent these regulations clarify or explain this collection process, they are necessary for the protection of public health, safety and welfare. The regulations are clearly written and easily understandable. Finally, these regulations meet, but do not exceed, statutory authority.
