This is a new regulation pursuant to §24.2-410.2 Security of the Virginia Voter Registration System, in which the State Board of Elections is required to "promulgate regulations and standards necessary" to ensure the security of the Virginia voter registration system (VERIS). This law also requires the Department of Elections to limit access to VERIS to address and resolve security risks, or enforce compliance with the Locality Election Security Standards.

This regulation requires that all VERIS uses be required to participate in a Security Awareness Training program.

**Mandate and Impetus**

As per its charter, the Voter Registration System Security (VRSS) Advisory Group is asked to provide recommendations and insight to the Board to heighten the security of VERIS and supporting technologies. The VRSS recommended the State Board of Elections enact a regulation requiring that all VERIS users be required to participate in a Security Awareness Training program provided by their locality compliant with ELECT specifications, or participate in the no-cost to localities Security Awareness Training program provided by ELECT.

The State Board of Elections promulgated this regulation pursuant to its authority §24.2-410.2 of the Code of Virginia.
